COMMITTEE SUBSTITUTE

An Act relating to the ROA-25 Revolving Fund;
requiring transfer from certain fund to the ROA-25
Revolving Fund; authorizing certain transfer to the
ROA-25 Revolving Fund; establishing amounts;
providing certain budgeting and expenditure
requirements; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. TRANSFER The State Treasurer shall transfer to
the ROA-25 Revolving Fund created pursuant to Enrolled House Bill
No. 2781 of the 1st Regular Session of the 60th Oklahoma
Legislature, from the Perform Fund created in Section 3646.5 of
Title 68 of the Oklahoma Statutes, the sum of One Hundred Eighty
Million Dollars (\$180,000,000.00) to be budgeted and expended in
accordance with law.

1 SECTION 2. The Oklahoma Department of Commerce is hereby
2 authorized to transfer to the ROA-25 Revolving Fund created pursuant
3 to Enrolled House Bill No. 2781 of the 1st Regular Session of the
4 60th Oklahoma Legislature, from the monies appropriated to the
5 Oklahoma Department of Commerce by Section 1 of Enrolled Senate Bill
6 1179 of the 1st Session of the 59th Oklahoma Legislature the sum of
7 Seventy-five Million Dollars (\$75,000,000.00) to be budgeted and
8 expended in accordance with law.

9 SECTION 3. It being immediately necessary for the preservation
10 of the public peace, health or safety, an emergency is hereby
11 declared to exist, by reason whereof this act shall take effect and
12 be in full force from and after its passage and approval.
