**Bill Analysis**

SB 1732 increases license fees relating to the Home Inspection Licensing Act. The measure increases the Licensure for Reciprocity fee from \$50.00 to \$80.00, the License fee from \$250.00 to \$400.00, and the license renewal fee from \$150.00 to \$240.00. The measure eliminates the licenses for permit issuance and permit renewal from the Construction Industries Board and establishes fees for plumbing, electrical, or mechanical license at the following rates:

- 1) Initial contractor license \$480.00
- 2) Renewal contractor license \$320.00
- 3) Renewal contractor license with late fee \$480.00
- 4) Initial journeyman license \$80.00
- 5) Renewal journeyman license \$120.00
- 6) Renewal journeyman license with late fee \$160.00
- 7) Apprentice registration \$120.00
- 8) Initial alarm endorsement \$120.00
- 9) Renewal alarm endorsement \$120.00

The measure establishes fees for roofing licenses at the following rates:

- 1) Initial roofing contractor registration \$120.00
- 2) Initial roofing contractor registration by reciprocity \$120.00
- 3) Initial roofing endorsement by reciprocity \$320.00
- 4) Renewal of roofing contractor registration \$120.00
- 5) Initial commercial endorsement on roofing contractor registration \$320.00
- 6) Initial commercial endorsement on roofing contractor registration by reciprocity \$440.00
- 7) Renewal of commercial endorsement on roofing contractor registration \$160.00
- 8) Renewal of commercial endorsement on roofing contractor and registration by reciprocity \$280.00
- 9) Initial registration for registered roofing contractor with commercial endorsement \$440.00
- 10) Renewal registration for registered roofing contractor with commercial endorsement \$280.00

The measure establishes fee for home inspection industry licenses at the following rates:

- 1) Licensure for reciprocity \$80.00
- 2) License fee \$400.00
- 3) Renewal fee \$240.00

The measure also establishes a \$55.00 fee for the initial issuance or renewal of a license for building, electrical, mechanical, plumbing, or energy code inspectors, \$480.00 for an initial poultry house contractor license, and \$320.00 for a renewal poultry house contractor license.
