

CONFERENCE COMMITTEE SUBSTITUTE

An Act relating to schools; amending 70 O.S. 2021, Section 3-151.1, which relates to high school graduation rates; modifying calculation of the four-year and extended-year adjusted cohort graduation rates; prohibiting certain student transfers after certain date from being included in certain rate; updating statutory references; updating statutory language; amending 70 O.S. 2021, Section 1210.545, which relates to annual school reports for the Oklahoma School Testing Program; prohibiting chronic absenteeism from being included in certain measure; removing language requiring the percentage of certain grade to be based on certain indicators; directing certain number of points to be provided based on school site performance in certain areas; expanding items to be included as postsecondary opportunities; allowing school sites to be eligible for bonus points based on certain in-person classroom instruction and improvement in certain rate; directing the State Board of Education to amend and submit certain plan by certain date; updating statutory language; providing an effective date; and declaring an emergency.

1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 SECTION 1. AMENDATORY 70 O.S. 2021, Section 3-151.1, is
3 amended to read as follows:

4 Section 3-151.1. A. For purposes of establishing a uniform and
5 accurate definition of high school graduation rate for school
6 districts and secondary schools in ~~the~~ this state, the State Board
7 of Education shall adopt and implement a four-year adjusted cohort
8 graduation rate and an extended-year adjusted cohort graduation
9 rate. The Board shall utilize and report the four-year adjusted
10 cohort graduation rate and the extended-year adjusted cohort
11 graduation rate at the secondary school site, the school district,
12 and the state level, and the graduation rates shall be reported in
13 the aggregate as well as disaggregated by subgroups as required in
14 the Elementary and Secondary Education Act of ~~2001~~ 1965 (ESEA), as
15 reauthorized by P.L. No. 107-110 114-95, also known as the ~~No Child~~
16 ~~Left Behind Act of 2001~~ Every Student Succeeds Act (ESSA).

17 B. The Board shall use the four-year adjusted cohort graduation
18 rate for purposes of determining the high school graduation rate
19 indicator for the academic performance data calculation beginning
20 with state and district report cards providing results of
21 assessments administered in the 2011-2012 school year. The Board
22 shall use the four-year adjusted cohort graduation rate for
23 establishing the high school graduation rate for measuring alternate
24

1 year percentage growth targets as set forth in Section 3-151.2 of
2 this title beginning with the 2012-2013 school year.

3 C. The four-year adjusted cohort graduation rate shall be
4 defined as the number of students who graduate in four (4) years
5 with a standard high school diploma divided by the number of
6 students who entered high school four (4) years earlier, ~~adjusted~~
7 ~~for transfers in and~~. Students who transfer out of the school,
8 émigrés or emigrate to another country and deceased students shall
9 not be included in the adjusted cohort graduation rate. Twelfth-
10 grade students who transfer into a school after October 1 of any
11 school year shall not be included in the adjusted cohort graduation
12 rate. Students who graduate in four (4) years shall include
13 students who earn a standard high school diploma at the end of their
14 fourth year, before the end of their fourth year, and during a
15 summer session immediately following their fourth year. To remove a
16 student from a cohort, a school district shall confirm in writing or
17 by electronic means that a student has transferred out of the school
18 site or school district, has emigrated to another country, or is
19 deceased. For a student who transfers out of a school site or
20 school district, the written or electronic confirmation shall be
21 official and document that the student has enrolled in another
22 school site or school district or in an educational program that
23 culminates in a high school diploma recognized by a state or private
24 higher educational institution accredited or recognized by the

1 Oklahoma State Regents for Higher Education for purposes of
2 admission to the institution. Students who are not enrolled in a
3 program which culminates in the award of a credential recognized by
4 a state or private higher educational institution for purposes of
5 admissions shall not be included in the graduation rate calculation
6 as set forth in this subsection as a student who graduated in four
7 (4) years with a standard high school diploma but shall be included
8 in the number of students who entered high school four (4) years
9 earlier.

10 D. The extended-year adjusted cohort graduation rate shall be
11 defined as the number of students who graduate in four (4) years or
12 five (5) years with a high school diploma divided by the number of
13 students who form the adjusted cohort for the four-year graduation
14 rate as calculated as provided for in subsection C of this section,
15 ~~provided that the adjustments add to the cohort all students who~~
16 ~~transfer into the cohort by the end of the year of graduation being~~
17 ~~considered and subtract students who transfer out, emigrate to~~
18 ~~another country or are deceased by the end of that year.~~ The
19 extended-year adjusted cohort graduation rate shall be reported
20 separately from the four-year adjusted cohort graduation rate.

21 SECTION 2. AMENDATORY 70 O.S. 2021, Section 1210.545, is
22 amended to read as follows:

23 Section 1210.545. A. Except as otherwise provided, as part of
24 the accountability system developed as provided for in Section

1 1210.541 of this title, the State Board of Education shall prepare
2 annual reports of the results of the Oklahoma School Testing Program
3 which describe student achievement in the state, and each school
4 site, pursuant to the Elementary and Secondary Education Act of 1965
5 (ESEA) as reauthorized by P.L. No. 114-95, also known as the Every
6 Student Succeeds Act (ESSA), and any related federal regulations.

7 B. The annual report as required pursuant to subsection A of
8 this section shall identify school sites as having one of the
9 following grades for each indicator, separately, and by a single
10 overview grade of all indicators, defined according to rules of the
11 State Board of Education:

- 12 1. "A" means schools making excellent progress;
- 13 2. "B" means schools making above average progress;
- 14 3. "C" means schools making satisfactory progress;
- 15 4. "D" means schools making less than satisfactory progress;

16 and

- 17 5. "F" means schools failing to make adequate progress.

18 C. Each school that has students who are tested and included in
19 the school grading system as provided for in this section shall
20 receive a school grade, except as follows:

- 21 1. A school shall not receive a school grade if the number of
22 students tested and included in the school grading system is less
23 than the minimum sample size necessary for statistical reliability
24 and prevention of the unlawful release of personally identifiable

1 student data. The State Board of Education is directed to establish
2 the lowest minimum sample size necessary to meet the requirements of
3 this paragraph; and

4 2. The academic performance of students who are enrolled full-
5 time in an online program that is offered by a school district or
6 charter school that is not the district of residence or is not
7 located in the district of residence of the student shall be
8 reported separately by the school district or charter school and
9 shall not be included when determining the grade of the school site
10 or charter school.

11 D. The State Board of Education may adopt alternate systems of
12 accountability for statewide virtual charter schools, alternative
13 education programs as defined in Section 1210.568 of this title, and
14 schools serving only grades prekindergarten or kindergarten through
15 two.

16 E. The grade of a school shall be based on a multimeasures
17 approach to accountability in accordance with the Elementary and
18 Secondary Education Act of 1965 (ESEA) as reauthorized by P.L. No.
19 114-95, also known as the Every Student Succeeds Act (ESSA) and any
20 federal regulations that include, but are not limited to, the
21 following indicators:

22 1. Statewide assessments, including the establishment of
23 student performance bands;

24 2. Graduation rates for high schools;

1 3. Statewide academic measures for elementary and middle
2 schools;

3 4. English language proficiency for English learners; and

4 5. At least one additional statewide measure of school quality
5 or student success, including, but not limited to, school climate,
6 school safety, student engagement, educator engagement, and/or
7 advanced coursework and postsecondary readiness. Chronic
8 absenteeism shall not be included as a statewide measure of school
9 quality or student success.

10 ~~F. Of the indicators included in subsection E of this section,~~
11 ~~not less than seventy percent (70%) of the overview grade must be~~
12 ~~given to indicators 1, 2, 3 and 4 and, in the aggregate, with not~~
13 ~~more than thirty percent (30%) of the grade given to indicator 5.~~

14 ~~G. Further, the~~ The grade of an elementary or middle school
15 site shall include, but not be limited to, ~~a:~~

16 1. Up to forty (40) points based on a measure of status for
17 English language arts (ELA), math, and science;

18 2. Up to thirty-five (35) points based on growth in ELA and
19 math; and

20 3. Up to ten (10) points based on English Language Proficiency
21 Assessment language proficiency assessment (ELPA) progress, ~~and~~
22 ~~chronic absenteeism.~~

23 ~~H.~~ G. The grade of a high school site shall include, but not be
24 limited to, ~~a:~~

1 1. Up to fifty-five (55) points based on a measure of status
2 for English language arts (ELA), math, and science ~~status~~;

3 2. Up to ten (10) points based on English ~~Language Proficiency~~
4 ~~Assessment~~ language proficiency assessment (ELPA) progress;

5 3. Up to ten (10) points based on the graduation rate, ~~chronic~~
6 ~~absenteeism~~; and

7 4. Up to ten (10) points based on postsecondary opportunities.

8 For purposes of this section, postsecondary opportunities shall

9 include ~~Advanced Placement~~ advanced placement, International

10 Baccalaureate, dual and concurrent enrollment, scoring Silver level

11 or above on American College Testing (ACT) WorkKeys, internships,

12 mentorships and apprenticeships, military readiness as evidenced by

13 being accepted for enlistment into any branch of the military within

14 the first year after high school graduation or earning a military

15 readiness score on the Armed Services Vocational Aptitude Battery

16 (ASVAB), and industry certifications. The Board shall adopt a ~~time~~

17 ~~line~~ timeline for moving from completion of such opportunities to

18 crediting achievement of such opportunities.

19 ~~F.~~ H. Elementary, middle, and high school sites shall be

20 eligible for the following bonus point amounts to be used in the

21 calculation of the site's single overview grade:

22 1. Up to three (3) bonus points if the school site provides in-

23 person classroom instruction in excess of the requirements of

24 paragraphs 1 and 2 of subsection A of Section 1-109 of this title,

1 not including in-person classroom instruction time used for
2 professional development or parent-teacher conferences; and

3 2. Up to two (2) bonus points if the school site's chronic
4 absenteeism rate shows improvement.

5 I. The annual report shall identify the performance of each
6 school as having improved, remained the same, or declined. This
7 school improvement rating shall be based on a comparison of the
8 student and school performance data of the current year to the
9 previous year data.

10 J. The State Department of Education shall annually develop a
11 school site report card to be delivered to parents or legal
12 guardians throughout each school district. The report card shall be
13 in accordance with the requirements of the Elementary and Secondary
14 Education Act of 1965 (ESEA),⁷ as reauthorized and amended by P.L.
15 No. 114-95, also known as the Every Student Succeeds Act (ESSA),¹ and
16 ~~includes~~ include the grade for the school, information regarding
17 school improvement, an explanation of school performance, and
18 indicators of return on investment. The report card for each school
19 site shall be published annually by the Department on its website,
20 and every school district shall provide the school site report card
21 to the parent or legal guardian of each student enrolled in the
22 school site. In order to provide information regarding school
23 performance for school report cards issued during the 2016-2017 and
24 2017-2018 school ~~year~~ years, the Department shall include an

1 explanation of the changes to the statewide system of student
2 assessments as required in Section 1210.508 of this title and how
3 the transition in assessments may impact school performance. The
4 Department shall issue school report cards using the 2016-2017
5 school year assessment data that is available.

6 K. The Legislature may factor in the performance of schools in
7 calculating any performance-based funding policy that is provided to
8 public school districts.

9 L. The State Board of Education shall amend the ESSA
10 consolidated State plan in accordance with the requirements of the
11 Every Student Succeeds Act (ESSA) to replace the measure of chronic
12 absenteeism to reflect the provisions of this section. The Board
13 shall submit the proposed amendment to the United States Department
14 of Education no later than August 1, 2025.

15 ~~L.~~ M. The State Board of Education shall promulgate rules to
16 implement the provisions of this section.

17 SECTION 3. This act shall become effective July 1, 2025.

18 SECTION 4. It being immediately necessary for the preservation
19 of the public peace, health, or safety, an emergency is hereby
20 declared to exist, by reason whereof this act shall take effect and
21 be in full force from and after its passage and approval.
