1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 SECTION 1. AMENDATORY 68 O.S. 2021, Section 1357.21, as
3 last amended by Section 1, Chapter 273, O.S.L. 2024 (68 O.S. Supp.
4 2024, Section 1357.21), is amended to read as follows:

5 Section 1357.21. A. The exemption authorized by the provisions
6 of paragraph 43 of Section 1357 of this title shall be administered
7 as a rebate. The rebate program shall be administered by the
8 Oklahoma Broadband Office and the Oklahoma Tax Commission.

9 B. No claim for a rebate shall be approved unless the equipment
10 was purchased in order to establish or expand broadband services in
11 underserved or unserved areas. As used in this subsection and for
12 purposes of the exemption authorized by paragraph 43 of Section 1357
13 of this title, "broadband", "underserved", and "unserved" shall mean
14 those services and areas as defined in Section 139.102 of Title 17
15 of the Oklahoma Statutes.

16 C. No claim for rebate shall be approved unless the claimant
17 establishes that as a result of the equipment purchase there has
18 been net growth in the number of potential customers served in
19 underserved or unserved areas.

20 D. In order to qualify for rebate payments ~~during the fiscal~~
21 ~~year beginning July 1, 2022,~~ for equipment or other items qualifying
22 for the exemption authorized by paragraph 43 of Section 1357 of this

3 SECTION 2. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 1357.22 of Title 68, unless
5 there is created a duplication in numbering, reads as follows:

6 A. There is hereby created in the State Treasury a revolving
7 fund for the Oklahoma Tax Commission to be designated the "Oklahoma
8 Broadband Rebate Revolving Fund". The fund shall be a continuing
9 fund, not subject to fiscal year limitations, and shall consist of
10 all monies received by the Tax Commission which are specifically
11 required by law to be deposited in the fund. All monies accruing to
12 the credit of the fund are hereby appropriated and may be budgeted
13 and expended by the Commission for the purpose of paying rebate
14 claims pursuant to Section 1357.21 of Title 68 of the Oklahoma
15 Statutes. Expenditures from the fund shall be made upon warrants
16 issued by the State Treasurer against claims filed as prescribed by
17 law with the Director of the Office of Management and Enterprise
18 Services for approval and payment.

14 ending June 30, 2023, the sum of Fifteen Million Dollars
15 (\$15,000,000.00) to be transferred to the Oklahoma Broadband Rebate
16 Revolving Fund created pursuant to Section 2 of this act.

17 SECTION 6. This act shall become effective July 1, 2025.

18 SECTION 7. It being immediately necessary for the preservation
19 of the public peace, health or safety, an emergency is hereby
20 declared to exist, by reason whereof this act shall take effect and
21 be in full force from and after its passage and approval.
