PROPOSED COMMITTEE SUBSTITUTE

An Act relating to the Ethics Commission; amending 74  
O.S. 2021, Section 4258.1, which relates to the  
Political Subdivisions Enforcement Fund; increasing  
fund cap; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 74 O.S. 2021, Section 4258.1, is  
amended to read as follows:

Section 4258.1. There is hereby created in the State Treasury a  
revolving fund for the Ethics Commission to be designated the  
"Political Subdivisions Enforcement Fund". The fund shall be a  
continuing fund, not subject to fiscal year limitations, and shall  
consist of all funds appropriated by the Legislature to the fund and

1 all late filing fees, fines from settlement agreements and fines  
2 assessed by the District Court for violations of the County Campaign  
3 Finance and Financial Disclosure Act, the Municipal Campaign Finance  
4 and Financial Disclosure Act, and the Technology Center District and  
5 Independent School District Campaign Finance and Financial  
6 Disclosure Act. All monies accruing to the credit of the fund are  
7 hereby appropriated and may be budgeted and expended by the  
8 Commission for any expenses incurred by the Political Subdivisions  
9 Enforcement Division. Expenditures from the fund shall be made upon  
10 warrants issued by the State Treasurer against claims filed as  
11 prescribed by law with the Director of the Office of Management and  
12 Enterprise Services for approval and payment. No later than January  
13 31, 2016, and every year thereafter, the State Treasurer shall  
14 transfer to the General Revenue Fund of the state any monies in the  
15 fund in excess of ~~One Hundred Fifty Thousand Dollars (\$150,000.00)~~  
16 Four Hundred Fifty Thousand Dollars (\$450,000.00). If at any time  
17 the amount of money in the fund is less than One Hundred Thousand  
18 Dollars (\$100,000.00), the Executive Director of the Commission may  
19 order that there be no further enforcement by the Political  
20 Subdivisions Enforcement Division until the amount of money in the  
21 fund is more than One Hundred Thousand Dollars (\$100,000.00).

22 SECTION 2. It being immediately necessary for the preservation  
23 of the public peace, health or safety, an emergency is hereby  
24

1 declared to exist, by reason whereof this act shall take effect and  
2 be in full force from and after its passage and approval.
