8	A Joint Resolution directing the Secretary of State to refer to the people for their approval or
9	rejection a proposed amendment to Section 3 of Article VII-B of the Constitution of the State of
10	Oklahoma; updating references to congressional districts; modifying provisions related to terms of
11	office; removing restrictions based on membership in political party; removing restrictions based upon
12	status as licensed attorney; removing restriction based upon status of family members as licensed
13	attorneys; removing restriction related to succession in office; prohibiting consecutive service for
14	certain time period; updating statutory language; providing ballot title; and directing filing.

17	BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE
18	1ST SESSION OF THE 60TH OKLAHOMA LEGISLATURE:
19	SECTION 1. The Secretary of State shall refer to the people for
20	their approval or rejection, as and in the manner provided by law,
21	the following proposed amendment to Section 3 of Article VII-B of
22	the Constitution of the State of Oklahoma to read as follows:

Section 3. (a) There is established as a part of the Judicial
 Department a Judicial Nominating Commission of fifteen (15) members,
 to consist of:

six members to be appointed by the Governor, which shall 4 (1)5 include at least one from each congressional district established by the Statutes of Oklahoma and existing at the date of the adoption of 6 this Article, none of whom shall be admitted to practice law in the 7 State of Oklahoma or have any immediate family member who has been 8 9 admitted to the practice of law in the State of Oklahoma or any 10 other state as such congressional districts exist as of the date of the appointment. Each member shall serve a term of six (6) years; 11 (2) six members, which shall include at least one from each 12 congressional district established by the Statutes of Oklahoma and 13 existing at the date of the adoption of this Article as such 14 congressional districts exist as of the date of the appointment who 15 are, however, members of the Oklahoma Bar Association and who have 16 17 been elected by the other active members of their district under procedures adopted by the Board of Governors of the Oklahoma Bar 18 Association, until changed by statute. Each member shall serve a 19 term of six (6) years; and 20

(3) three members at large who shall not have been admitted to
the practice of law in the State of Oklahoma or any other state or
have any immediate family member who has been admitted to the
practice of law in the State of Oklahoma or any other state but who,

1 each of whom shall be a resident of the State of Oklahoma, one to be selected by not less than eight members of the Judicial Nominating 2 Commission. Each member shall serve a term of six (6) years. 3 In the event eight members of the Commission cannot agree upon the 4 5 member at large within thirty (30) days of the initial organization of the Commission or within thirty (30) days of a vacancy in the 6 member at large position, the Governor shall make the appointment of 7 the member at large; one to member shall be selected by the 8 9 President Pro Tempore of the Senate; and one to member shall be selected by the Speaker of the House of Representatives. No more 10 than two members at large shall belong to any one political party. 11 12 (b) The Commission shall elect one of its members to serve as chair for a term of one (1) year. 13

The six lay members of the Commission who are appointed by the 14 Governor shall be appointed within ninety (90) days from the date 15 that this Article becomes effective. Two members shall be appointed 16 for a term of two (2) years, two members for a term of four (4) 17 years, and two members for a term of six (6) years. The Oklahoma 18 Bar Association shall hold its election and certify to the Secretary 19 of State its members within ninety (90) days from the effective date 20 of this Article, two of whom shall be elected for a term of two (2) 21 years, two for a term of four (4) years, and two for a term of six 22 (6) years. Thereafter all (c) All of the members of the 23 Commission, whether elected or appointed, shall serve for a term of 24

1 six (6) years, except that the member at large shall serve for a
2 term of two (2) years.

3 (b) (d) Vacancies arising during the term of any lay
4 commissioner, other than the member at large, shall be filled by
5 appointment by the Governor for the remainder of his or her term.
6 Vacancies of any lawyer commissioner shall be filled by the Board of
7 Governors of the Oklahoma Bar Association for the remainder of his
8 or her term.

9 (c) (e) In the event of vacancy in the member at large 10 position, the said vacancy shall be filled in the same manner as the 11 original selection.

12 (d) Of those Commissioners named by the Governor, not more than 13 three shall belong to any one political party.

14 (e) (f) The concurrence of the majority of Commissioners in 15 office at the time shall be sufficient to decide any question, 16 unless otherwise provided herein. The Commission shall have 17 jurisdiction to determine whether the qualifications of nominees to 18 hold Judicial Office have been met and to determine the existence of 19 vacancies on the Commission.

20 (f) (g) No Commissioner, while a member of the Commission,
21 shall hold any other public office by election or appointment or any
22 official position in a political party and he or she shall not be
23 eligible, while a member of the Commission and for five (5) years
24 thereafter, for nomination as a Judicial Officer.

1 (q) (h) Commissioners shall serve without compensation but the 2 Legislature shall provide funds to reimburse them for their necessary travel and lodging expenses while performing their duties 3 as such Commissioners. 4 5 (h) No Commissioner shall be permitted to succeed himself or 6 herself No Commissioner shall serve more than twelve (12) consecutive years, whether elected or appointed. 7 As used herein, the words "Oklahoma Bar Association" shall 8 (i) 9 include any successor thereof and any future form of the organized Bar of this state. 10 SECTION 2. The Ballot Title for the proposed Constitutional 11 12 amendment as set forth in SECTION 1 of this resolution shall be in the following form: 13 BALLOT TITLE 14 Legislative Referendum No. State Question No. 15 THE GIST OF THE PROPOSITION IS AS FOLLOWS: 16 This measure amends Section 3 of Article 7-B of the Oklahoma 17 Constitution. It changes provisions related to the Judicial 18 Nominating Commission. It updates references so that 19 appointments made by certain persons based on the congressional 20 districts would be made using the current congressional 21 districts instead of the districts as they were constituted when 22 this section of the Constitution was originally adopted in 1967. 23 It removes a prohibition on certain members of the Commission so 24

1	that the member could be a licensed attorney. It allows a
2	person to serve on the Commission even if he or she is related
3	to a licensed attorney. It changes the terms so that each term
4	would be for six (6) years. It removes restrictions based on
5	political party membership. It removes a provision that
6	prohibits a member of the Commission from succeeding himself or
7	herself on the Commission.
