7 An Act relating to municipal audits; re-creating the  
8 Special Investigative Unit Auditing Revolving Fund;  
9 providing funding sources; providing purpose of fund;  
10 providing for codification; providing an effective  
11 date; and declaring an emergency.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. NEW LAW A new section of law to be codified  
14 in the Oklahoma Statutes as Section 17-107B of Title 11, unless  
15 there is created a duplication in numbering, reads as follows:

16 There is hereby re-created in the State Treasury a revolving  
17 fund for the State Auditor and Inspector to be designated the  
18 "Special Investigative Unit Auditing Revolving Fund". The fund  
19 shall be a continuing fund, not subject to fiscal year limitations,  
20 and shall consist of all monies received by the State Auditor and  
21 Inspector from funds withheld from a municipality's allocations of  
22 gasoline taxes as provided in Section 17-107 of Title 11 of the  
23 Oklahoma Statutes, all monies received from legislative  
24 appropriations for the purpose of conducting investigative municipal

1 audits, and all monies that remain in the Special Investigative Unit  
2 Auditing Revolving Fund created under Section 17-107A of Title 11 of  
3 the Oklahoma Statutes. All monies accruing to the credit of such  
4 fund are hereby appropriated and may be budgeted and expended by the  
5 State Auditor and Inspector for the purpose of offsetting expenses  
6 incurred from special investigative audit activities relating to  
7 municipal government. Expenditures from the fund shall be made upon  
8 warrants issued by the State Treasurer against claims filed as  
9 prescribed by law with the Director of the Office of Management and  
10 Enterprise Services for approval and payment.

11 SECTION 2. This act shall become effective July 1, 2025.

12 SECTION 3. It being immediately necessary for the preservation  
13 of the public peace, health or safety, an emergency is hereby  
14 declared to exist, by reason whereof this act shall take effect and  
15 be in full force from and after its passage and approval.
