A. Unless otherwise specifically defined, "per-16 pupil expenditure" shall mean the aggregate current expenditures of 17 school districts, from all funding sources including federal funds, 18 state funds and local funds, plus the direct support aggregate current expenditures of the state for the day-to-day operations of 19 20 schools and school districts from all funding sources including 21 federal funds, divided by the aggregate student membership number 22 for the same fiscal year for which the expenditures are determined. 23 The aggregate student membership number shall be the count of

students enrolled on October 1 or the school day closest to October
