8 expenses of various agencies, authorities, boards,  
9 bureaus, commissions, funds, and programs of the  
10 state's legislative, executive, and judicial  
11 branches; making appropriations, stating amounts,  
12 identifying sources, and providing expenditure  
13 purposes, mandates, and limitations to the State  
14 Board of Education, Teachers' Retirement System  
15 Dedicated Revenue Revolving Fund, the Oklahoma Board  
16 of Private Vocational Schools, the Commissioners of  
17 the Land Office, the Health Care Workforce Training  
18 Commission, the Office of Educational Quality and

the Domestic Violence and Sexual Assault Services  
Revolving Fund, the Oklahoma Sheriff's Office Funding  
Assistance Revolving Fund, the Council on Judicial  
Complaints, the District Attorneys Council, the  
Oklahoma Indigent Defense System, the Pardon and  
Parole Board, the Court of Criminal Appeals, the  
district courts, the Supreme Court, Ad Valorem  
Reimbursement Fund, the Special Cash Fund, the Legacy  
Capital Finance Fund, the Progressing Rural Economic  
Prosperity Fund, and the Oklahoma Emission Reduction  
Technology Downstream Incentive Revolving Fund;  
authorizing and directing certain expenditures,  
redesignation, and transfers of funds; clarifying  
execution under certain conditions; and providing an  
effective date.

1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 EDUCATION

3 SECTION 1. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 General Revenue Fund of the State Treasury for the fiscal year  
6 ending June 30, 2026, the sum of One Billion Six Hundred Fifty-one  
7 Million Four Hundred Sixty Thousand Four Hundred Thirteen Dollars  
8 (\$1,651,460,413.00) or so much thereof as may be necessary for the  
9 financial support of public schools.

10 SECTION 2. There is hereby appropriated to the State Board of  
11 Education from any monies not otherwise appropriated from the  
12 Education Reform Revolving Fund, created in Section 34.89 of Title  
13 62 of the Oklahoma Statutes, the sum of One Billion Two Hundred  
14 Sixty-two Million Seven Hundred Thirty-five Thousand Three Hundred  
15 Fifty-three Dollars (\$1,262,735,353.00) or so much thereof as may be  
16 necessary for the financial support of public schools.

17 SECTION 3. The State Board of Education is hereby authorized to  
18 expend during the fiscal year ending June 30, 2026, from the Common  
19 Education Technology Revolving Fund of the State Treasury, the sum  
20 of Forty-seven Million Dollars (\$47,000,000.00) or so much thereof  
21 as may be necessary for the financial support of public schools.

22 SECTION 4. There is hereby appropriated to the State Board of  
23 Education from any monies not otherwise appropriated from the  
24 Mineral Leasing Fund of the State Treasury for the fiscal year

1 ending June 30, 2026, the sum of Four Million Nine Hundred Forty  
2 Thousand Dollars (\$4,940,000.00) or so much thereof as may be  
3 necessary for the financial support of public schools.

4 SECTION 5. There is hereby appropriated to the State Board of  
5 Education from any monies not otherwise appropriated from the  
6 Mineral Leasing Fund of the State Treasury for the fiscal year  
7 ending June 30, 2024, the sum of Three Hundred Forty-four Thousand  
8 Five Hundred Thirty-one Dollars (\$344,531.00) or so much thereof as  
9 may be necessary for the financial support of public schools.

10 SECTION 6. There is hereby appropriated to the State Board of  
11 Education from any monies not otherwise appropriated from the  
12 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
13 fiscal year ending June 30, 2026, the sum of Twenty-seven Million  
14 Seven Hundred Eighty-seven Thousand Five Hundred Dollars  
15 (\$27,787,500.00) or so much thereof as may be necessary for the  
16 financial support of public schools.

17 SECTION 7. There is hereby appropriated to the State Board of  
18 Education from any monies not otherwise appropriated from the  
19 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
20 fiscal year ending June 30, 2024, the sum of One Million Four  
21 Hundred Sixty-two Thousand Five Hundred Dollars (\$1,462,500.00) or  
22 so much thereof as may be necessary for the financial support of  
23 public schools.

1       SECTION 8. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 General Revenue Fund of the State Treasury for the fiscal year  
4 ending June 30, 2026, the sum of One Hundred Twenty-five Million One  
5 Hundred Eighty-nine Thousand Twenty-six Dollars (\$125,189,026.00) or  
6 so much thereof as may be necessary for the financial support of  
7 public school activities.

8       SECTION 9. There is hereby appropriated to the State Board of  
9 Education from any monies not otherwise appropriated from the  
10 General Revenue Fund of the State Treasury for the fiscal year  
11 ending June 30, 2026, the sum of Four Hundred Ten Million Eight  
12 Hundred Fifty-one Thousand One Hundred Fifty-nine Dollars  
13 (\$410,851,159.00) or so much thereof as may be necessary for the  
14 Certified Employee Health Benefit Allowance.

15       SECTION 10. There is hereby appropriated to the State Board of  
16 Education from any monies not otherwise appropriated from the  
17 General Revenue Fund of the State Treasury for the fiscal year  
18 ending June 30, 2026, the sum of Two Hundred Forty-seven Million  
19 Seven Hundred Twenty-three Thousand Four Hundred Eighteen Dollars  
20 (\$247,723,418.00) or so much thereof as may be necessary for the  
21 Support Personnel Health Benefit Allowance.

22       SECTION 11. There is hereby appropriated to the State Board of  
23 Education from any monies not otherwise appropriated from the  
24 General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2026, the sum of Eighteen Million One Hundred Forty-  
2 five Thousand Three Hundred Sixty-six Dollars (\$18,145,366.00) or so  
3 much thereof as may be necessary for the administration and support  
4 functions of the State Department of Education.

5 SECTION 12. There is hereby appropriated to the State Board of  
6 Education from any monies not otherwise appropriated from the  
7 General Revenue Fund of the State Treasury for the fiscal year  
8 ending June 30, 2026, the sum of Forty-five Million One Hundred  
9 Ninety Thousand Dollars (\$45,190,000.00) or so much thereof as may  
10 be necessary for the purchase of textbooks and instructional  
11 materials.

12 SECTION 13. There is hereby appropriated to the State Board of  
13 Education from any monies not otherwise appropriated from the  
14 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
15 fiscal year ending June 30, 2026, the sum of Three Million Eighty-  
16 seven Thousand Five Hundred Dollars (\$3,087,500.00) or so much  
17 thereof as may be necessary for transfer to the School Consolidation  
18 Assistance Fund.

19 SECTION 14. There is hereby appropriated to the State Board of  
20 Education from any monies not otherwise appropriated from the  
21 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
22 fiscal year ending June 30, 2024, the sum of One Hundred Sixty-two  
23 Thousand Five Hundred Dollars (\$162,500.00) or so much thereof as  
24 may be necessary for transfer to the School Consolidation Assistance

1 Fund. The State Board of Education is hereby authorized to transfer  
2 such amount to the Teachers' Retirement System of Oklahoma.

3 SECTION 15. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
6 fiscal year ending June 30, 2026, the sum of Three Million Eighty-  
7 seven Thousand Five Hundred Dollars (\$3,087,500.00) or so much  
8 thereof as may be necessary for transfer to the Teachers' Retirement  
9 System Dedicated Revenue Revolving Fund. The State Board of  
10 Education is hereby authorized to transfer such amount to the  
11 Teachers' Retirement System of Oklahoma.

12 SECTION 16. There is hereby appropriated to the State Board of  
13 Education from any monies not otherwise appropriated from the  
14 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
15 fiscal year ending June 30, 2024, the sum of One Hundred Sixty-two  
16 Thousand Five Hundred Dollars (\$162,500.00) or so much thereof as  
17 may be necessary for transfer to the Teachers' Retirement System  
18 Dedicated Revenue Revolving Fund.

19 SECTION 17. There is hereby appropriated to the State Board of  
20 Education from any monies not otherwise appropriated from the  
21 General Revenue Fund of the State Treasury for the fiscal year  
22 ending June 30, 2026, the sum of Two Million Six Hundred Fifty  
23 Thousand Dollars (\$2,650,000.00) for the purpose of compensating  
24

1 teachers as defined by Section 1-116 of Title 70 of the Oklahoma  
2 Statutes.

3 SECTION 18. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 General Revenue Fund of the State Treasury for the fiscal year  
6 ending June 30, 2026, the sum of One Hundred Twenty-five Million  
7 Dollars (\$125,000,000.00) to be distributed as redbud school grants  
8 as provided in Section 3-104 of Title 70 of the Oklahoma Statutes.

9 SECTION 19. There is hereby appropriated to the State Board of  
10 Education from any monies not otherwise appropriated from the  
11 General Revenue Fund of the State Treasury for the fiscal year  
12 ending June 30, 2026, the sum of Six Million Five Hundred Thousand  
13 Dollars (\$6,500,000.00) to be transferred to the Public School Paid  
14 Maternity Leave Revolving Fund (294) pursuant to the provisions of  
15 Section 6-104.8 of Title 70 of the Oklahoma Statutes.

16 SECTION 20. For the fiscal year ending June 30, 2026, the State  
17 Board of Education is hereby authorized to transfer from the  
18 Teachers' Retirement System Dedicated Revenue Revolving Fund to the  
19 Teachers' Retirement System of Oklahoma, the sum of Four Hundred  
20 Thirty-three Million Nine Hundred Thirty-five Thousand Two Hundred  
21 Thirty-two Dollars (\$433,935,232.00).

22 SECTION 21. There is hereby appropriated to the Oklahoma Board  
23 of Private Vocational Schools from any monies not otherwise  
24 appropriated from the General Revenue Fund of the State Treasury for



1 the fiscal year ending June 30, 2026, the sum of Two Hundred Fifty  
2 Thousand Dollars (\$250,000.00) or so much thereof as may be  
3 necessary to perform the duties imposed upon the Board by law.

4 SECTION 22. There is hereby appropriated to the Commissioners  
5 of the Land Office from any monies not otherwise appropriated from  
6 the Commissioners of the Land Office Fund of the State Treasury for  
7 the fiscal year ending June 30, 2026, the sum of Six Million Seven  
8 Hundred Three Thousand Four Hundred Twenty-one Dollars  
9 (\$6,703,421.00) or so much thereof as may be necessary to perform  
10 the duties imposed upon the Office by law.

11 SECTION 23. There is hereby appropriated to the Health Care  
12 Workforce Training Commission from any monies not otherwise  
13 appropriated from the General Revenue Fund of the State Treasury for  
14 the fiscal year ending June 30, 2026, the sum of Ten Million Four  
15 Hundred Seventy-six Thousand Seven Hundred Fourteen Dollars  
16 (\$10,476,714.00) or so much thereof as may be necessary to perform  
17 the duties imposed upon the Commission by law. Of the funds  
18 appropriated in this section, the sum of Two Million Three Hundred  
19 Twenty Thousand Dollars (\$2,320,000.00) shall be used to carry out  
20 the provisions of Section 3308.1 of Title 70 of the Oklahoma  
21 Statutes.

22 SECTION 24. There is hereby appropriated to the Office of  
23 Educational Quality and Accountability from any monies not otherwise  
24 appropriated from the General Revenue Fund of the State Treasury for

1 the fiscal year ending June 30, 2026, the sum of Three Million Six  
2 Hundred Ninety-seven Thousand Two Hundred Nine Dollars  
3 (\$3,697,209.00) or so much thereof as may be necessary to perform  
4 the duties imposed upon the Office by law. Of those funds  
5 appropriated, the sum of Sixty Thousand Dollars (\$60,000.00) shall  
6 be deposited in the Teaching Certification Scholarship Revolving  
7 Fund, created pursuant to Section 6-187C of Title 70 of the Oklahoma  
8 Statutes. Of those funds appropriated, the sum of One Hundred  
9 Eighty Thousand Dollars (\$180,000.00) shall be deposited in the  
10 Education Leadership Oklahoma Revolving Fund, created pursuant to  
11 Section 6-204.3 of Title 70 of the Oklahoma Statutes.

12 SECTION 25. There is hereby appropriated to the Oklahoma Arts  
13 Council from any monies not otherwise appropriated from the General  
14 Revenue Fund of the State Treasury for the fiscal year ending June  
15 30, 2026, the sum of Four Million Three Hundred Eight Thousand One  
16 Hundred Eighty Dollars (\$4,308,180.00) or so much thereof as may be  
17 necessary to perform the duties imposed upon the Council by law.

18 SECTION 26. There is hereby appropriated to the Oklahoma Center  
19 for the Advancement of Science and Technology from any monies not  
20 otherwise appropriated from the General Revenue Fund of the State  
21 Treasury for the fiscal year ending June 30, 2026, the sum of  
22 Seventeen Million Three Hundred Forty-six Thousand Five Hundred  
23 Forty-two Dollars (\$17,346,542.00) or so much thereof as may be  
24 necessary to perform the duties imposed upon the Center by law. Of

1 those funds appropriated, the sum of Eight Million Two Hundred  
2 Fifty-six Thousand Two Hundred Twenty-eight Dollars (\$8,256,228.00)  
3 shall be deposited in the Research Support Revolving Fund, created  
4 pursuant to Section 5060.11 of Title 74 of the Oklahoma Statutes,  
5 provided that Three Million Dollars (\$3,000,000.00) shall be  
6 dedicated to applied research and development for industry  
7 innovation. Of those funds appropriated, Five Hundred Thousand  
8 Dollars (\$500,000.00) shall be dedicated to the Research and  
9 Development Attraction Program, created pursuant to Section 5003.10g  
10 of Title 74 of the Oklahoma Statutes. Of those funds appropriated,  
11 the sum of One Million Two Hundred Thirty-five Thousand Six Hundred  
12 Twenty-three Dollars (\$1,235,623.00) shall be deposited in the Seed-  
13 Capital Revolving Fund, created pursuant to Section 5060.21 of Title  
14 74 of the Oklahoma Statutes.

15 SECTION 27. There is hereby appropriated to the Oklahoma  
16 Department of Libraries from any monies not otherwise appropriated  
17 from the General Revenue Fund of the State Treasury for the fiscal  
18 year ending June 30, 2026, the sum of Five Million Seven Hundred  
19 Twenty-eight Thousand Three Hundred Fifty-eight Dollars  
20 (\$5,728,358.00) or so much thereof as may be necessary to perform  
21 the duties imposed upon the Department by law.

22 SECTION 28. There is hereby appropriated to the Oklahoma  
23 Educational Television Authority from any monies not otherwise  
24 appropriated from the General Revenue Fund of the State Treasury for

1 the fiscal year ending June 30, 2026, the sum of Two Million Nine  
2 Hundred Fifty-four Thousand Four Dollars (\$2,954,004.00) or so much  
3 thereof as may be necessary to perform the duties imposed upon the  
4 Authority by law.

5 SECTION 29. There is hereby appropriated to the Oklahoma State  
6 Regents of Higher Education from any monies not otherwise  
7 appropriated from the General Revenue Fund of the State Treasury for  
8 the fiscal year ending June 30, 2026, the sum of Eight Hundred  
9 Seventy-two Million Four Hundred Thirty-five Thousand Twenty-seven  
10 Dollars (\$872,435,027.00) or so much thereof as may be necessary for  
11 allocation by the Oklahoma State Regents for Higher Education  
12 pursuant to the provisions of Article XIII-A of the Oklahoma  
13 Constitution for the education and general operating budgets of the  
14 institutions and for other programs, construction, renovations, or  
15 repairs administered by the Oklahoma State Regents for Higher  
16 Education. Of those funds appropriated, the sum of Three Million  
17 One Hundred Forty-nine Thousand Eight Hundred Ninety-seven Dollars  
18 (\$3,149,897.00) shall be transferred to the Oklahoma Tuition  
19 Equalization Grant Trust Fund to implement the provisions of the  
20 Oklahoma Tuition Equalization Grant Act, and the sum of Twelve  
21 Million Five Hundred Thousand Dollars (\$12,500,000.00) shall be  
22 transferred to the Oklahoma National Guard Educational Assistance  
23 Revolving Fund, created in Section 3232 of Title 70 of the Oklahoma  
24 Statutes.

1       SECTION 30. The Office of Management and Enterprise Services is  
2 authorized to transfer to the Oklahoma State Regents of Higher  
3 Education during the fiscal year ending July 1, 2026, an amount of  
4 Seventy Million Dollars (\$70,000,000.00) designated for the support  
5 of the Oklahoma Higher Learning Access Program.

6       SECTION 31. There is hereby appropriated to the Oklahoma State  
7 Regents of Higher Education from any monies not otherwise  
8 appropriated from the General Revenue Fund of the State Treasury for  
9 the fiscal year ending June 30, 2026, the sum of Seven Hundred Forty  
10 Thousand Three Hundred Ten Dollars (\$740,310.00) for the benefit of  
11 the Oklahoma Higher Learning Access Program.

12       SECTION 32. The Oklahoma State Regents for Higher Education are  
13 hereby authorized to expend during the fiscal year ending June 30,  
14 2026, the sum of Forty-seven Million Dollars (\$47,000,000.00) from  
15 the Higher Education Capital Revolving Fund of the State Treasury  
16 for allocation by the Oklahoma State Regents for Higher Education  
17 pursuant to the provisions of Article XIII-A of the Oklahoma  
18 Constitution for the education and general operating budgets of the  
19 institutions for other programs, construction, renovations, or  
20 repairs administered by the Oklahoma State Regents for Higher  
21 Education.

22       SECTION 33. The Oklahoma State Regents for Higher Education are  
23 hereby authorized to expend during the fiscal year ending June 30,  
24 2026, the sum of Forty-seven Million Dollars (\$47,000,000.00) from

1 the Oklahoma Student Aid Revolving Fund of the State Treasury for  
2 allocation by the Oklahoma State Regents for Higher Education  
3 pursuant to the provisions of Article XIII-A of the Oklahoma  
4 Constitution for the education and general operating budgets of the  
5 institutions for other programs, construction, renovations, or  
6 repairs administered by the Oklahoma State Regents for Higher  
7 Education.

8 SECTION 34. There is hereby appropriated to the Oklahoma State  
9 Regents for Higher Education from any monies not otherwise  
10 appropriated from the Oklahoma Education Lottery Trust Fund of the  
11 State Treasury for the fiscal year ending June 30, 2026, the sum of  
12 Twenty-four Million Three Hundred Ninety-one Thousand Two Hundred  
13 Fifty Dollars (\$24,391,250.00) pursuant to Section 713 of Title 3A  
14 of the Oklahoma Statutes for allocation by the Oklahoma State  
15 Regents for Higher Education pursuant to the provisions of Article  
16 XIII-A of the Oklahoma Constitution for construction, renovations,  
17 or repairs administered by the Oklahoma State Regents for Higher  
18 Education or for any other purpose authorized by Section 713 of  
19 Title 3A of the Oklahoma Statutes.

20 SECTION 35. There is hereby appropriated to the Oklahoma State  
21 Regents for Higher Education from any monies not otherwise  
22 appropriated from the Oklahoma Education Lottery Trust Fund of the  
23 State Treasury for the fiscal year ending June 30, 2024, the sum of  
24 One Million Two Hundred Eighty-three Thousand Seven Hundred Fifty

1 Dollars (\$1,283,750.00) pursuant to Section 713 of Title 3A of the  
2 Oklahoma Statutes for allocation by the Oklahoma State Regents for  
3 Higher Education pursuant to the provisions of Article XIII-A of the  
4 Oklahoma Constitution for construction, renovations, or repairs  
5 administered by the Oklahoma State Regents for Higher Education or  
6 for any other purpose authorized by Section 713 of Title 3A of the  
7 Oklahoma Statutes.

8       SECTION 36. There is hereby appropriated to the Oklahoma State  
9 Regents for Higher Education from any monies not otherwise  
10 appropriated from the General Revenue Fund of the State Treasury for  
11 the fiscal year ending June 30, 2026, the sum of Eighteen Million  
12 Eight Hundred Twenty-two Thousand Six Hundred Fifteen Dollars  
13 (\$18,822,615.00) for expenditures for concurrent enrollment pursuant  
14 to Section 628.13 of Title 70 of the Oklahoma Statutes.

15       SECTION 37. There is hereby appropriated to the Oklahoma State  
16 Regents for Higher Education from any monies not otherwise  
17 appropriated from the General Revenue Fund of the State Treasury for  
18 the fiscal year ending June 30, 2024, the sum of Four Million Two  
19 Hundred Thirty-two Thousand Nine Hundred Seventy-four Dollars  
20 (\$4,232,974.00) for the general operating budget of the  
21 administrative offices of the Oklahoma State Regents for Higher  
22 Education.

23       SECTION 38. There is hereby appropriated to the Oklahoma State  
24 Regents for Higher Education from any monies not otherwise

1 appropriated from the General Revenue Fund of the State Treasury for  
2 the fiscal year ending June 30, 2024, the sum of Twelve Million Five  
3 Hundred Thousand Dollars (\$12,500,000.00) for the purpose of  
4 purchasing casualty and property insurance.

5 SECTION 39. There is hereby appropriated to the Board of

16 (\$15,537,314.00) or so much thereof as may be necessary for the  
17 financial support of the district courts.

18 SECTION 140. There is hereby appropriated to the Supreme Court  
19 from any monies not otherwise appropriated from the General Revenue  
20 Fund of the State Treasury for the fiscal year ending June 30, 2026,  
21 the sum of Seventy-one Million Four Hundred Twenty-two Thousand Nine  
22 Hundred Eighty-three Dollars (\$71,422,983.00) or so much thereof as  
23 may be necessary to perform the duties imposed upon the district  
24 courts by law.



1       SECTION 141. There is hereby appropriated to the Supreme Court  
2 from any monies not otherwise appropriated from the General Revenue  
3 Fund of the State Treasury for the fiscal year ending June 30, 2024,  
4 the sum of Sixteen Million Ninety-three Thousand Thirty-seven  
5 Dollars (\$16,093,037.00) or so much thereof as may be necessary to  
6 perform the duties imposed upon the Supreme Court or Court of Civil  
7 Appeals by law.

8       SECTION 142. There is hereby appropriated to the Supreme Court  
9 from any monies not otherwise appropriated from the General Revenue  
10 Fund of the State Treasury for the fiscal year ending June 30, 2025,  
11 the sum of Twelve Million Seven Hundred Sixty-five Thousand Seven  
12 Hundred Fifty-two Dollars (\$12,765,752.00) or so much thereof as may  
13 be necessary to perform the duties imposed upon the Supreme Court or  
14 Court of Civil Appeals by law. Of the funds appropriated herein,  
15 the Supreme Court is authorized to transfer up to Ten Million Five  
16 Hundred Thousand Dollars (\$10,500,000.00) to the Family  
17 Representation and Advocacy Program Revolving Fund, created by  
18 Section 802 of Title 10 of the Oklahoma Statutes, to implement the  
19 provisions of the Family Representation and Advocacy Act.

22 Commission from any monies not otherwise appropriated from the

12 Forty-eight Thousand Two Hundred Ninety-two Dollars (\$64,848,292.00)  
13 to be transferred to the Ad Valorem Reimbursement Fund, created  
14 pursuant to Section 193 of Title 62 of the Oklahoma Statutes, for  
15 the purpose of reimbursing counties for school districts that claim  
16 a loss of revenue due to a tax exemption granted pursuant to the  
17 provisions of Section 6B of Article X of the Oklahoma Constitution.

18 SECTION 145. There is hereby appropriated to the State Board of  
19 Education from any monies not otherwise appropriated from the  
20 Education Reform Revolving Fund, created in Section 34.89 of Title  
21 62 of the Oklahoma Statutes, the sum of Eleven Million Four Hundred  
22 Fifty-three Thousand One Hundred Thirteen Dollars (\$11,453,113.00)  
23 or so much thereof as may be necessary for the Certified Employee  
24 Health Benefit Allowance.

1       SECTION 146. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 General Revenue Fund of the State Treasury for the fiscal year  
4 ending June 30, 2023, the sum of Ten Million Five Hundred Fifty-nine  
5 Thousand Four Hundred Forty-one Dollars (\$10,559,441.00) or so much  
6 thereof as may be necessary for the Support Personnel Health Benefit  
7 Allowance.

8       SECTION 147. There is hereby appropriated to the Department of  
9 Mental Health and Substance Abuse Services from any monies not  
10 otherwise appropriated from the General Revenue Fund of the State  
11 Treasury for the fiscal year ending June 30, 2024, the sum of  
12 Twenty-seven Million Four Hundred Four Thousand Seven Hundred Fifty-  
13 eight Dollars (\$27,404,758.00) for the payment of agency payroll.

14       SECTION 148. REDESIGNATION From the funds appropriated to the  
15 Department of Mental Health and Substance Abuse Services in Enrolled  
16 Senate Bill No. 1125 of the 2nd Session of the 59th Oklahoma  
17 Legislature, the sum of Four Million One Hundred Thousand Dollars  
18 (\$4,100,000.00), notwithstanding the limitation provided in Section  
19 3 of Enrolled House Bill No. 2929 of the 2nd Session of the 59th  
20 Oklahoma Legislature, shall be redesignated and available to the  
21 Department of Mental Health and Substance Abuse Services for the  
22 payment of agency payroll.

23       SECTION 149. There is hereby appropriated to the Special Cash  
24 Fund of the State Treasury from any monies not otherwise

12 ending June 30, 2026, the sum of Four Hundred Ninety-one Million Six  
13 Hundred Thousand Dollars (\$491,600,000.00) to be administered in  
14 accordance with law.

15       SECTION 156. There is hereby appropriated to the Progressing  
16 Rural Economic Prosperity Fund, created in Section 256 of Title 62  
17 of the Oklahoma Statutes, from any monies not otherwise appropriated  
18 from the General Revenue Fund of the State Treasury for the fiscal  
19 year ending June 30, 2023, the sum of Fifty-eight Million Dollars  
20 (\$58,000,000.00) for availability of appropriation.

21       SECTION 157. There is hereby appropriated to the Department of  
22 Commerce from any monies not otherwise appropriated from the General  
23 Revenue Fund of the State Treasury for the fiscal year ending June  
24 30, 2026, the sum of Three Million Dollars (\$3,000,000.00) to

1 facilitate and support ongoing efforts in workforce development,  
2 enhance manufacturing and supply chain capabilities, and support the  
3 expansion of research and development, and commercialization  
4 activities in this state.

5 SECTION 158. There is hereby appropriated to the Military  
6 Department of the State of Oklahoma from any monies not otherwise  
7 appropriated from the General Revenue Fund of the State Treasury for  
8 the fiscal year ending June 30, 2026, the sum of Twenty-one Million  
9 Dollars (\$21,000,000.00) or so much thereof as may be necessary to  
10 enhance and improve military bases and facilities in Oklahoma. The  
11 Military Department is authorized to transfer monies appropriated in  
12 this section to the BIND - Schools Fund created in Enrolled House  
13 Bill No. 2516 of the 1st Regular Session of the 60th Oklahoma

22 Dollars (\$20,000,000.00), to the Oklahoma Emission Reduction  
23 Technology Downstream Incentive Revolving Fund created in subsection

1 | B of Section 55010 of Title 68 of the Oklahoma Statutes, to be  
2 | utilized in accordance with law.

SECTION 160. There is hereby appropriated to the Oklahoma State Regents for Higher Education, from any monies not otherwise appropriated from the Progressing Rural Economic Prosperity Fund, created in Section 256 of Title 62 of the Oklahoma Statutes, the sum of Twenty Million Dollars (\$20,000,000.00) for institutional utilization.

9           SECTION 161. Appropriations, authorizations, and distributions  
10 directed in this act to or from a revolving fund of the State  
11 Treasury enacted during the 1st Session of the 60th Oklahoma  
12 Legislature shall be executable upon the latter of the effective  
13 date for such applicable section of this act or upon date of such  
14 fund's creation.

15       SECTION 162. Sections 1 through 142, 155, 157, and 158 of this  
16 act shall become effective July 1, 2025.
