11 An Act relating to retirement; amending 74 O.S. 2021,  
12 Sections 902, as last amended by Section 1, Chapter  
13 280, O.S.L. 2024 (74 O.S. Supp. 2025, Section 902),  
14 915, as amended by Section 2, Chapter 280, O.S.L.  
15 2024 (74 O.S. Supp. 2025, Section 915), 916.3, as  
16 amended by Section 3, Chapter 280, O.S.L. 2024 (74  
17 O.S. Supp. 2025, Section 916.3), 919.1, as amended by  
18 Section 4, Chapter 280, O.S.L. 2024 (74 O.S. Supp.  
19 2025, Section 919.1), and 935.2, which relate to the  
20 Oklahoma Public Employees Retirement System; defining  
21 term; modifying term; providing retirement benefit  
22 computation for certain members; modifying who shall  
23 receive monthly pension; updating references;  
24 modifying employee contributions for certain  
employees; providing an effective date; and declaring  
an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 74 O.S. 2021, Section 902, as last  
amended by Section 1, Chapter 280, O.S.L. 2024 (74 O.S. Supp. 2025,  
Section 902), is amended to read as follows:

1 Section 902. As used in Section 901 et seq. of this title:

2 (1) "System" means the Oklahoma Public Employees Retirement  
3 System as established by Section 901 et seq. of this title and as it  
4 may hereafter be amended;

5 (2) "Accumulated contributions" means the sum of all  
6 contributions by a member to the System which shall be credited to  
7 the member's account;

8 (3) "Act" means Sections 901 to 932, inclusive, of this title;

9 (4) "Actuarial equivalent" means a deferred income benefit of  
10 equal value to the accumulated deposits or benefits when computed  
11 upon the basis of the actuarial tables in use by the System;

12 (5) "Actuarial tables" means the actuarial tables approved and  
13 in use by the Board at any given time;

14 (6) "Actuary" means the actuary or firm of actuaries employed  
15 by the Board at any given time;

16 (7) "Beneficiary" means any person named by a member to receive  
17 any benefits as provided for by Section 901 et seq. of this title.  
18 If there is no beneficiary living at time of member employee's  
19 death, the member's estate shall be the beneficiary;

20 (8) "Board" means the Oklahoma Public Employees Retirement  
21 System Board of Trustees;

22 (9) "CLEET-certified law enforcement agent employed by the  
23 Department of Human Services Office of Inspector General" means  
24 those persons hired by the Department of Human Services Office of

1 Inspector General on or after June 1, 1993, who are certified by the  
2 Council on Law Enforcement Education and Training or an equivalent  
3 certifying entity for law enforcement personnel training and who  
4 perform law enforcement services as part of their regularly assigned  
5 duties and responsibilities on a full-time basis;

6 (10) "Compensation" means all salary and wages, as defined by  
7 the Board of Trustees, including amounts deferred under deferred  
8 compensation agreements entered into between a member and a  
9 participating employer, but exclusive of payment for overtime,  
10 payable to a member of the System for personal services performed  
11 for a participating employer but shall not include compensation or  
12 reimbursement for traveling, or moving expenses, or any compensation  
13 in excess of the maximum compensation level, provided:

14 (a) For compensation for service prior to January 1, 1988,  
15 the maximum compensation level shall be Twenty-five  
16 Thousand Dollars (\$25,000.00) per annum.

17 For compensation for service on or after January 1,  
18 1988, through June 30, 1994, the maximum compensation  
19 level shall be Forty Thousand Dollars (\$40,000.00) per  
20 annum.

21 For compensation for service on or after July 1, 1994,  
22 through June 30, 1995, the maximum compensation level  
23 shall be Fifty Thousand Dollars (\$50,000.00) per  
24 annum; for compensation for service on or after July

1, 1995, through June 30, 1996, the maximum compensation level shall be Sixty Thousand Dollars (\$60,000.00) per annum; for compensation for service on or after July 1, 1996, through June 30, 1997, the maximum compensation level shall be Seventy Thousand Dollars (\$70,000.00) per annum; and for compensation for service on or after July 1, 1997, through June 30, 1998, the maximum compensation level shall be Eighty Thousand Dollars (\$80,000.00) per annum. For compensation for services on or after July 1, 1998, there shall be no maximum compensation level for retirement purposes.

(b) Compensation for retirement purposes shall include any amount of elective salary reduction under Section 457 of the Internal Revenue Code of 1986 and any amount of nonelective salary reduction under Section 414(h) of the Internal Revenue Code of 1986.

(c) Notwithstanding any provision to the contrary, the compensation taken into account for any employee in determining the contribution or benefit accruals for any plan year is limited to the annual compensation limit under Section 401(a)(17) of the federal Internal Revenue Code.

1 (d) Current appointed members of the Oklahoma Tax  
2 Commission whose salary is constitutionally limited  
3 and is less than the highest salary allowed by law for  
4 his or her position shall be allowed, within ninety  
5 (90) days from March 21, 2001, to make an election to  
6 use the highest salary allowed by law for the position  
7 to which the member was appointed for the purposes of  
8 making contributions and determination of retirement  
9 benefits. Such election shall be irrevocable and be  
10 in writing. Reappointment to the same office shall  
11 not permit a new election. Members appointed to the  
12 Oklahoma Tax Commission after the March 21, 2001,  
13 shall make such election, pursuant to this  
14 subparagraph, within ninety (90) days of taking  
15 office;

16 ~~(10)~~ (11) "Credited service" means the sum of participating  
17 service, prior service and elected service;

18 ~~(11)~~ (12) "Dependent" means a parent, child, or spouse of a  
19 member who is dependent upon the member for at least one-half (1/2)  
20 of the member's support;

21 ~~(12)~~ (13) "Effective date" means the date upon which the System  
22 becomes effective by operation of law;

23 ~~(13)~~ (14) "Eligible employer" means the state and any county,  
24 county hospital, city or town, conservation districts, circuit

1 engineering districts and any public or private trust in which a  
2 county, city or town participates and is the primary beneficiary, is  
3 to be an eligible employer for the purpose of Section 901 et seq. of  
4 this title only, whose employees are covered by Social Security and  
5 are not covered by or eligible for another retirement plan  
6 authorized under the laws of this state which is in operation on the  
7 initial entry date. Emergency medical service districts may join  
8 the System upon proper application to the Board. Provided,  
9 affiliation by a county hospital shall be in the form of a  
10 resolution adopted by the board of control.

11 (a) If a class or several classes of employees of any  
12 above-defined employers are covered by Social Security  
13 and are not covered by or eligible for and will not  
14 become eligible for another retirement plan authorized  
15 under the laws of this state, which is in operation on  
16 the effective date, such employer shall be deemed an  
17 eligible employer, but only with respect to that class  
18 or those classes of employees as defined in this  
19 section.

20 (b) A class or several classes of employees who are  
21 covered by Social Security and are not covered by or  
22 eligible for and will not become eligible for another  
23 retirement plan authorized under the laws of this  
24 state, which is in operation on the effective date,

1 and when the qualifications for employment in such  
2 class or classes are set by state law; and when such  
3 class or classes of employees are employed by a county  
4 or municipal government pursuant to such  
5 qualifications; and when the services provided by such  
6 employees are of such nature that they qualify for  
7 matching by or contributions from state or federal  
8 funds administered by an agency of state government  
9 which qualifies as a participating employer, then the  
10 agency of state government administering the state or  
11 federal funds shall be deemed an eligible employer,  
12 but only with respect to that class or those classes  
13 of employees as defined in this subsection; provided,  
14 that the required contributions to the retirement plan  
15 may be withheld from the contributions of state or  
16 federal funds administered by the state agency and  
17 transmitted to the System on the same basis as the  
18 employee and employer contributions are transmitted  
19 for the direct employees of the state agency. The  
20 retirement or eligibility for retirement under the  
21 provisions of law providing pensions for service as a  
22 volunteer firefighter shall not render any person  
23 ineligible for participation in the benefits provided  
24 for in Section 901 et seq. of this title. An employee

1 of any public or private trust in which a county, city  
2 or town participates and is the primary beneficiary  
3 shall be deemed to be an eligible employee for the  
4 purpose of Section 901 et seq. of this title only.

5 (c) All employees of the George Nigh Rehabilitation  
6 Institute who elected to retain membership in the  
7 System, pursuant to Section 913.7 of this title, shall  
8 continue to be eligible employees for the purposes of  
9 Section 901 et seq. of this title. The George Nigh  
10 Rehabilitation Institute shall be considered a  
11 participating employer only for such employees.

12 (d) All employees of CompSource Mutual Insurance Company  
13 who retain membership in the Oklahoma Public Employees  
14 Retirement System pursuant to Section 913.9 of this  
15 title shall continue to be eligible employees for the  
16 purposes of the Oklahoma Public Employees Retirement  
17 System. CompSource Mutual Insurance Company shall be  
18 considered a participating employer only for such  
19 employees.

20 (e) All employees of a successor organization, as defined  
21 by Section 5-60.12 of Title 2 of the Oklahoma  
22 Statutes, who retain membership in the Oklahoma Public  
23 Employees Retirement System pursuant to Section 5-  
24 60.35 of Title 2 of the Oklahoma Statutes shall

1 continue to be eligible employees for the purposes of  
2 the Oklahoma Public Employees Retirement System. A  
3 successor organization shall be considered a  
4 participating employer only for such employees.

5 (f) A participating employer of the Teachers' Retirement  
6 System of Oklahoma, who has one or more employees who  
7 have made an election pursuant to enabling legislation  
8 to retain membership in the System as a result of  
9 change in administration, shall be considered a  
10 participating employer of the Oklahoma Public  
11 Employees Retirement System only for such employees;

12 ~~(14)~~ (15) "Employee" means any officer or employee of a  
13 participating employer, whose employment is not seasonal or  
14 temporary and whose employment requires at least one thousand  
15 (1,000) hours of work per year and whose salary or wage is equal to  
16 the hourly rate of the monthly minimum wage for state employees.  
17 For those eligible employers outlined in Section 910 of this title,  
18 the rate shall be equal to the hourly rate of the monthly minimum  
19 wage for that employer. Each employer, whose minimum wage is less  
20 than the state's minimum wage, shall inform the System of the  
21 minimum wage for that employer. This notification shall be by  
22 resolution of the governing body.

- 1 (a) Any employee of the county extension agents who is not  
2 currently participating in the Teachers' Retirement  
3 System of Oklahoma shall be a member of this System.
- 4 (b) Eligibility shall not include any employee who is a  
5 contributing member of the United States Civil Service  
6 Retirement System.
- 7 (c) It shall be mandatory for an officer, appointee or  
8 employee of the office of district attorney to become  
9 a member of this System if he or she is not currently  
10 participating in a county retirement system. Provided  
11 further, that if an officer, appointee or employee of  
12 the office of district attorney is currently  
13 participating in such county retirement system, he or  
14 she is ineligible for this System as long as he or she  
15 is eligible for such county retirement system. Any  
16 eligible officer, appointee or employee of the office  
17 of district attorney shall be given credit for prior  
18 service as defined in this section. The provisions  
19 outlined in Section 917 of this title shall apply to  
20 those employees who have previously withdrawn their  
21 contributions.
- 22 (d) Eligibility shall also not include any officer or  
23 employee of the Oklahoma Employment Security  
24 Commission, except for those officers and employees of

1 the Commission electing to transfer to this System  
2 pursuant to the provisions of Section 910.1 of this  
3 title or any other class of officers or employees  
4 specifically exempted by the laws of this state,  
5 unless there be a consolidation as provided by Section  
6 912 of this title. Employees of the Oklahoma  
7 Employment Security Commission who are ineligible for  
8 enrollment in the Oklahoma Employment Security  
9 Commission Retirement Plan, that was in effect on  
10 January 1, 1964, shall become members of this System.

- 11 (e) Any employee employed by the Legislative Service  
12 Bureau, Senate or House of Representatives for the  
13 full duration of a regular legislative session shall  
14 be eligible for membership in the System regardless of  
15 classification as a temporary employee and may  
16 participate in the System during the regular  
17 legislative session at the option of the employee.  
18 For purposes of this subparagraph, the determination  
19 of whether an employee is employed for the full  
20 duration of a regular legislative session shall be  
21 made by the Legislative Service Bureau if such  
22 employee is employed by the Legislative Service  
23 Bureau, the Senate if such employee is employed by the  
24 Senate, or by the House of Representatives if such

1 employee is employed by the House of Representatives.  
2 Each regular legislative session during which the  
3 legislative employee or an employee of the Legislative  
4 Service Bureau participates full time shall be counted  
5 as six (6) months of full-time participating service.

6 (i) Except as otherwise provided by this  
7 subparagraph, once a temporary session employee  
8 makes a choice to participate or not, the choice  
9 shall be binding for all future legislative  
10 sessions during which the employee is employed.

11 (ii) Notwithstanding the provisions of division (i) of  
12 this subparagraph, any employee, who is eligible  
13 for membership in the System because of the  
14 provisions of this subparagraph and who was  
15 employed by the Senate or House of  
16 Representatives after January 1, 1989, may file  
17 an election, in a manner specified by the Board,  
18 to participate as a member of the System prior to  
19 September 1, 1989.

20 (iii) Notwithstanding the provisions of division (i) of  
21 this subparagraph, a temporary legislative  
22 session employee who elected to become a member  
23 of the System may withdraw from the System  
24 effective the day such employee elected to

1 participate in the System upon written request to  
2 the Board. Any such request must be received by  
3 the Board prior to October 1, 1990. All employee  
4 contributions made by the temporary legislative  
5 session employee shall be returned to the  
6 employee without interest within four (4) months  
7 of receipt of the written request.

- 8 (iv) A member of the System who did not initially  
9 elect to participate as a member of the System  
10 pursuant to this subparagraph shall be able to  
11 acquire service performed as a temporary  
12 legislative session employee for periods of  
13 service performed prior to the date upon which  
14 the person became a member of the System if:
- 15 a. the member files an election with the System  
16 not later than December 31, 2000, to  
17 purchase the prior service; and
  - 18 b. the member makes payment to the System of  
19 the actuarial cost of the service credit  
20 pursuant to subsection A of Section 913.5 of  
21 this title. The provisions of Section 913.5  
22 of this title shall be applicable to the  
23 purchase of the service credit, including  
24 the provisions for determining service

1 credit in the event of incomplete payment  
2 due to cessation of payments, death,  
3 termination of employment or retirement, but  
4 the payment may extend for a period not to  
5 exceed ninety-six (96) months;

6 ~~(15)~~ (16) "Entry date" means the date on which an eligible  
7 employer joins the System. The first entry date pursuant to Section  
8 901 et seq. of this title shall be January 1, 1964;

9 ~~(16)~~ (17) "Executive Director" means the managing officer of  
10 the System employed by the Board under Section 901 et seq. of this  
11 title;

12 ~~(17)~~ (18) "Federal Internal Revenue Code" means the federal  
13 Internal Revenue Code of 1954 or 1986, as amended and as applicable  
14 to a governmental plan as in effect on July 1, 1999;

15 ~~(18)~~ (19) "Final average compensation" means the average annual  
16 compensation, including amounts deferred under deferred compensation  
17 agreements entered into between a member and a participating  
18 employer, up to, but not exceeding the maximum compensation levels  
19 as provided in paragraph (9) of this section received during the  
20 highest three (3) of the last ten (10) years of participating  
21 service immediately preceding retirement or termination of  
22 employment and with respect to members whose first participating  
23 service occurs on or after July 1, 2013, the compensation received  
24 during the highest five (5) of the last ten (10) years of

1 participating service immediately preceding retirement or  
2 termination of employment. Provided, no member shall retire with a  
3 final average compensation unless the member has made the required  
4 contributions on such compensation, as defined by the Board of  
5 Trustees;

6 ~~(19)~~ (20) "Fiscal year" means the period commencing July 1 of  
7 any year and ending June 30 of the next year. The fiscal year is  
8 the plan year for purposes of the federal Internal Revenue Code;  
9 however, the calendar year is the limitation year for purposes of  
10 Section 415 of the federal Internal Revenue Code;

11 ~~(20)~~ (21) "Fund" means the Oklahoma Public Employees Retirement  
12 Fund as created by Section 901 et seq. of this title;

13 ~~(21)~~ (22) "Leave of absence" means a period of absence from  
14 employment without pay, authorized and approved by the employer and  
15 acknowledged to the Board, and which after the effective date does  
16 not exceed two (2) years;

17 ~~(22)~~ (23) "Member" means an eligible employee or elected  
18 official who is in the System and is making the required employee or  
19 elected official contributions, or any former employee or elected  
20 official who shall have made the required contributions to the  
21 System and shall have not received a refund or withdrawal;

22 ~~(23)~~ (24) "Military service" means service in the Armed Forces  
23 of the United States by an honorably discharged person during the  
24 following time periods, as reflected on such person's Defense

1 Department Form 214, not to exceed five (5) years for combined  
2 participating and/or prior service, as follows:

3 (a) during the following periods, including the beginning  
4 and ending dates, and only for the periods served,  
5 from:

6 (i) April 6, 1917, to November 11, 1918, commonly  
7 referred to as World War I,

8 (ii) September 16, 1940, to December 7, 1941, as a  
9 member of the 45th Division,

10 (iii) December 7, 1941, to December 31, 1946, commonly  
11 referred to as World War II,

12 (iv) June 27, 1950, to January 31, 1955, commonly  
13 referred to as the Korean Conflict or the Korean  
14 War,

15 (v) February 28, 1961, to May 7, 1975, commonly  
16 referred to as the Vietnam era, except that:

17 a. for the period from February 28, 1961, to  
18 August 4, 1964, military service shall only  
19 include service in the Republic of Vietnam  
20 during that period, and

21 b. for purposes of determining eligibility for  
22 education and training benefits, such period  
23 shall end on December 31, 1976, or  
24

1 (vi) August 1, 1990, to December 31, 1991, commonly  
2 referred to as the Gulf War, the Persian Gulf  
3 War, or Operation Desert Storm, but excluding any  
4 person who served on active duty for training  
5 only, unless discharged from such active duty for  
6 a service-connected disability;

7 (b) during a period of war or combat military operation  
8 other than a conflict, war or era listed in  
9 subparagraph (a) of this paragraph, beginning on the  
10 date of Congressional authorization, Congressional  
11 resolution, or Executive Order of the President of the  
12 United States, for the use of the Armed Forces of the  
13 United States in a war or combat military operation,  
14 if such war or combat military operation lasted for a  
15 period of ninety (90) days or more, for a person who  
16 served, and only for the period served, in the area of  
17 responsibility of the war or combat military  
18 operation, but excluding a person who served on active  
19 duty for training only, unless discharged from such  
20 active duty for a service-connected disability, and  
21 provided that the burden of proof of military service  
22 during this period shall be with the member, who must  
23 present appropriate documentation establishing such  
24 service.

1 An eligible member under this paragraph shall include only those  
2 persons who shall have served during the times or in the areas  
3 prescribed in this paragraph, and only if such person provides  
4 appropriate documentation in such time and manner as required by the  
5 System to establish such military service prescribed in this  
6 paragraph, or for service pursuant to subdivision a of division (v)  
7 of subparagraph (a) of this paragraph those persons who were awarded  
8 service medals, as authorized by the United States Department of  
9 Defense as reflected in the veteran's Defense Department Form 214,  
10 related to the Vietnam Conflict for service prior to August 5, 1964;

11 ~~(24)~~ (25) "Normal retirement date" means the date on which a  
12 member may retire with full retirement benefits as provided in  
13 Section 901 et seq. of this title, such date being whichever occurs  
14 first:

15 (a) the first day of the month coinciding with or  
16 following a member's:

17 (1) sixty-second birthday with respect to members  
18 whose first participating service occurs prior to  
19 November 1, 2011, or

20 (2) sixty-fifth birthday with respect to members  
21 whose first participating service occurs on or  
22 after November 1, 2011, or with respect to  
23 members whose first participating service occurs  
24 on or after November 1, 2011, who reach a minimum

1 age of sixty (60) years and who also reach a  
2 normal retirement date pursuant to subparagraph c  
3 of this paragraph,

4 (b) for any person who initially became a member prior to  
5 July 1, 1992, and who does not reach a normal  
6 retirement date pursuant to division (1) of  
7 subparagraph (a) of this paragraph, the first day of  
8 the month coinciding with or following the date at  
9 which the sum of a member's age and number of years of  
10 credited service total eighty (80); such a normal  
11 retirement date will also apply to any person who  
12 became a member of the sending system as defined in  
13 Section 901 et seq. of this title, prior to July 1,  
14 1992, regardless of whether there were breaks in  
15 service after July 1, 1992,

16 (c) for any person who became a member after June 30,  
17 1992, but prior to November 1, 2011, and who does not  
18 reach a normal retirement date pursuant to division  
19 (1) of subparagraph (a) of this paragraph, the first  
20 day of the month coinciding with or following the date  
21 at which the sum of a member's age and number of years  
22 of credited service total ninety (90),

23 (d) in addition to subparagraphs (a), (b) and (c) of this  
24 paragraph, the first day of the month coinciding with

1 or following a member's completion of at least twenty  
2 (20) years of full-time-equivalent employment as:  
3 (i) a correctional or probation and parole officer  
4 with the Department of Corrections and at the  
5 time of retirement, the member was a correctional  
6 or probation and parole officer with the  
7 Department of Corrections,  
8 (ii) a correctional officer, probation and parole  
9 officer or fugitive apprehension agent with the  
10 Department of Corrections who is in such position  
11 on June 30, 2004, or who is hired after June 30,  
12 2004, and who receives a promotion or change in  
13 job classification after June 30, 2004, to  
14 another position in the Department of  
15 Corrections, so long as such officer or agent has  
16 at least five (5) years of service as a  
17 correctional officer, probation and parole  
18 officer or fugitive apprehension agent with the  
19 Department, has twenty (20) years of full-time-  
20 equivalent employment with the Department and was  
21 employed by the Department at the time of  
22 retirement,  
23 (iii) a firefighter with the Military Department of the  
24 State of Oklahoma either employed for the first

1 time on or after July 1, 2002, or who was  
2 employed prior to July 1, 2002, in such position  
3 and who makes the election authorized by division  
4 (2) of subparagraph b of paragraph (9) of  
5 subsection A of Section 915 of this title and at  
6 the time of retirement, the member was a  
7 firefighter with the Military Department of the  
8 State of Oklahoma, and such member has at least  
9 twenty (20) years of credited service upon which  
10 the two and one-half percent (2 1/2%) multiplier  
11 will be used in calculating the retirement  
12 benefit,

13 (iv) a public safety officer employed by the Grand  
14 River Dam Authority for the first time on or  
15 after July 1, 2016,

16 (v) a deputy sheriff or jailer employed by any county  
17 that is a participating employer in the System  
18 for the first time as a deputy sheriff or jailer  
19 on or after November 1, 2020, ~~or~~

20 (vi) beginning November 1, 2024, a deputy sheriff or  
21 jailer employed by any county that is a  
22 participating employer in the System for the  
23 first time as a deputy sheriff or jailer before  
24 November 1, 2020, including those who make the

1 election authorized by division (2) of  
2 subparagraph b of paragraph (10) of subsection A  
3 of Section 915 of this title, and at the time of  
4 retirement, if the member was a deputy sheriff or  
5 jailer employed by the participating county, and  
6 such member has at least twenty (20) years of  
7 credited service upon which the two and one-half  
8 percent (2 1/2%) multiplier will be used in  
9 calculating the retirement benefit, or

10 (vii) a CLEET-certified law enforcement agent employed  
11 by the Department of Human Services Office of  
12 Inspector General who is employed for the first  
13 time on or after July 1, 2026, or who was  
14 employed prior to July 1, 2026, as a CLEET-  
15 certified law enforcement agent and makes the  
16 election authorized by subparagraph (d) of  
17 paragraph (9) of subsection A of Section 915 of  
18 this title and, at the time of retirement, the  
19 member was a CLEET-certified law enforcement  
20 agent with the Department of Human Services  
21 Office of Inspector General, and such member has  
22 at least twenty (20) years of credited service,  
23 upon which the two and one-half percent (2 1/2%)

1                   multiplier will be used in calculating the  
2                   retirement benefit,

3           (e) for those fugitive apprehension agents who retire on  
4           or after July 1, 2002, the first day of the month  
5           coinciding with or following a member's completion of  
6           at least twenty (20) years of full-time-equivalent

18 issued by the Social Security Administration, Department of Health  
19 and Human Services or the Railroad Retirement Board. Disability  
20 benefits shall become effective on the date of entitlement as  
21 established by the Social Security Administration or the Railroad  
22 Retirement Board, but not before the first day of the month  
23 following removal from the payroll, whichever is later, and final  
24 approval by the Retirement System. Benefits shall be based upon

1 length of service and compensation as of the date of disability,  
2 without actuarial reduction because of commencement prior to the  
3 normal retirement date. The only optional form of benefit payment  
4 available for disability benefits is Option A as provided for in  
5 Section 918 of this title. Option A must be elected in accordance  
6 with the provisions of Section 918 of this title. Benefit payments  
7 shall cease upon the member's recovery from disability prior to the  
8 normal retirement date. Future benefits, if any, shall be paid  
9 based upon length of service and compensation as of the date of  
10 disability. In the event that disability ceases and the member  
11 returns to employment within the System credited service to the date  
12 of disability shall be restored, and future benefits shall be  
13 determined accordingly.

14 C. A member who incurred a disability pursuant to subsection B  
15 of this section on or after July 1, 1999, and who has retired from  
16 the System with an early retirement benefit pending certification  
17 from the Social Security Administration or the Railroad Retirement  
18 Board shall receive a retirement benefit not less than the  
19 disability retirement benefit provided by subsection B of this  
20 section once the System receives a Social Security Award Notice or a  
21 Railroad Retirement Award Notice pursuant to subsection B of this  
22 section and a completed Application for Disability Benefits. In  
23 addition, such member shall receive the difference, if any, between  
24 the early retirement benefit and the disability benefit from the

1 date the Social Security Administration or the Railroad Retirement  
2 Board establishes disability entitlement.

3 D. Any actively participating member of the System on or after  
4 July 1, 1998, except for those employees provided in subparagraph  
5 (e) of paragraph (14) of Section 902 of this title, whose employment  
6 is less than full-time, shall have his or her final average  
7 compensation calculated on an annualized basis using his or her  
8 hourly wage subject to the maximum compensation limits; provided,  
9 however, any such member whose first participating service occurred  
10 before July 1, 2013, and who has at least three (3) years of full-  
11 time employment during the last ten (10) years immediately preceding  
12 termination or retirement shall not be eligible for the  
13 annualization provisions contained herein; and provided further, any  
14 such member whose first participating service occurred on or after  
15 July 1, 2013, and who has at least five (5) years of full-time  
16 employment during the last ten (10) years immediately preceding  
17 termination or retirement shall not be eligible for the  
18 annualization provisions contained herein. The Board of Trustees  
19 shall promulgate such administrative rules as are necessary to  
20 implement the provisions of this subsection.

21 SECTION 3. AMENDATORY 74 O.S. 2021, Section 916.3, as  
22 amended by Section 3, Chapter 280, O.S.L. 2024 (74 O.S. Supp. 2025,  
23 Section 916.3), is amended to read as follows:  
24

1 Section 916.3. A. Notwithstanding the provisions of Sections  
2 901 through 932 of this title, a monthly pension, as provided in  
3 subsection B of this section, shall be paid on behalf of any member  
4 who is a:

5 1. Correctional officer or probation and parole officer of the  
6 Department of Corrections and who is killed or mortally wounded on  
7 or after January 1, 2000, during the performance of the member's  
8 duties for the Department or any employee of the Department of  
9 Corrections who is killed or mortally wounded after June 30, 2004,  
10 during the performance of the member's duties for the Department;

11 2. Deputy sheriff or county jailer first hired on or after  
12 November 1, 2020, by any county that is a participating member in  
13 the System, and who is killed or mortally wounded during the  
14 performance of the member's duties as a deputy sheriff or jailer;

15 ~~and~~

16 3. Deputy sheriff or county jailer first hired before November  
17 1, 2020, by any county that is a participating employer in the  
18 System, and who is killed or mortally wounded during the performance  
19 of the member's duties for the participating county on or after  
20 November 1, 2024; and

21 4. CLEET-certified law enforcement agent employed by the  
22 Department of Human Services Office of Inspector General and who is  
23 killed or mortally wounded on or after July 1, 2026, during the  
24 performance of the member's duties for the Department.

1 B. The monthly benefit shall be equal to:

2 1. Two and one-half percent (2 1/2%);

3 2. Multiplied by twenty (20) years of service, regardless of  
4 the actual number of years of credited service performed by the  
5 member prior to death, if the member had performed less than twenty  
6 (20) years of credited service, or the actual number of years of  
7 credited service of the member if greater than twenty (20) years;

8 3. Multiplied by the member's final average compensation; and

9 4. Divided by 12.

10 C. The pension provided for in subsection A of this section  
11 shall be paid:

12 1. Except as provided in subsection D of this section, to the  
13 surviving spouse for life; or

14 2. If there is no surviving spouse or upon the death of the  
15 surviving spouse:

16 a. to the surviving child or children of said member or  
17 legal guardian of such child or children for such time  
18 as such child or children are under the age of  
19 eighteen (18) years, or

20 b. to the surviving child or children between the age of  
21 eighteen (18) and twenty-two (22) years if the child  
22 is enrolled full time in and is regularly attending a  
23 public or private school or any institution of higher  
24 education.

1 D. No surviving spouse shall receive benefits from this  
2 section, Section 49-113 of Title 11 of the Oklahoma Statutes,  
3 Section 50-117 of Title 11 of the Oklahoma Statutes, or Section 2-  
4 306 of Title 47 of the Oklahoma Statutes as the surviving spouse of  
5 more than one member of the Oklahoma Firefighters Pension and  
6 Retirement System, the Oklahoma Police Pension and Retirement  
7 System, the Oklahoma Law Enforcement Retirement System, or the  
8 Oklahoma Public Employees Retirement System. The surviving spouse  
9 of more than one member shall elect which member's benefits he or  
10 she will receive.

11 E. In addition to the pension above provided for, if said  
12 member leaves one or more children under the age of eighteen (18)  
13 years or under the age of twenty-two (22) years if the child is  
14 enrolled full-time in and is regularly attending a public or private  
15 school or any institution of higher education, Four Hundred Dollars  
16 (\$400.00) a month shall be paid to the surviving spouse or to the  
17 person having the care and custody of such children if there is no  
18 surviving spouse or if the surviving spouse dies and until each  
19 child reaches the age of eighteen (18) years or reaches the age of  
20 twenty-two (22) years if the child is enrolled full-time in and is  
21 regularly attending a public or private school or any institution of  
22 higher education.

23 F. The pension benefit provided in this section shall be made  
24 prospectively only from the effective date of this act. The

1 benefits shall be payable beginning the later of the first day of  
 2 the month following the date that such employee was killed or dies  
 3 from a mortal wound, as provided in this section, or the effective  
 4 date of this act.

5 G. The Board of the Oklahoma Public Employees Retirement System  
 6 shall promulgate such rules as are necessary to implement the  
 7 provisions of this section.

8 SECTION 4. AMENDATORY 74 O.S. 2021, Section 919.1, as  
 9 amended by Section 4, Chapter 280, O.S.L. 2024 (74 O.S. Supp. 2025,  
 10 Section 919.1), is amended to read as follows:

11 Section 919.1. (1) Employee contributions to the System shall  
 12 be:

13 (a) for employees except as otherwise provided in  
 14 paragraphs (b), (c), (d), (e), (f) ~~and~~, (g), and (h)  
 15 of this subsection: beginning July 1, 2006, and  
 16 thereafter, three and one-half percent (3.5%) of  
 17 allowable annual compensation;

18 (b) for correctional officers and probation and parole  
 19 officers employed by the Department of Corrections:  
 20 beginning July 1, 1998, and thereafter, and for  
 21 correctional officers or probation and parole officers  
 22 who are in such position on June 30, 2004, or who are  
 23 hired after June 30, 2004, and who receive a promotion  
 24 or change in job classification after June 30, 2004,

1 to another position in the Department of Corrections,  
2 so long as such officers have at least five (5) years  
3 of service as a correctional officer or probation and  
4 parole officer, eight percent (8%) of allowable  
5 compensation as provided in paragraph (9) of Section  
6 902 of this title;

7 (c) for fugitive apprehension agents who are employed with  
8 the Department of Corrections on or after July 1,  
9 2002, and for fugitive apprehension agents who are in  
10 such position on June 30, 2004, or who are hired after  
11 June 30, 2004, and who receive a promotion or change  
12 in job classification after June 30, 2004, to another  
13 position in the Department of Corrections, so long as  
14 such agents have at least five (5) years of service as  
15 a fugitive apprehension agent, eight percent (8%) of  
16 allowable compensation as provided in paragraph (9) of  
17 Section 902 of this title;

18 (d) for firefighters of the Oklahoma Military Department  
19 first employed beginning July 1, 2002, and thereafter,  
20 and such firefighters who performed service prior to  
21 July 1, 2002, for the Oklahoma Military Department and  
22 who make the election authorized by division (1) of  
23 subparagraph b of paragraph (9) of subsection A of  
24 Section 915 of this title who perform service on or

1 after July 1, 2002, in such capacity, eight percent  
2 (8%) of allowable compensation as provided in  
3 subsection (9) of Section 902 of this title;

4 (e) for all public safety officers of the Grand River Dam  
5 Authority as defined by paragraph (37) of Section 902  
6 of this title, eight percent (8%) of allowable  
7 compensation as provided in paragraph (9) of Section  
8 902 of this title;

9 (f) for deputy sheriffs and county jailers employed by any  
10 county that is a participating employer in the System  
11 for the first time as a deputy sheriff or jailer on or  
12 after November 1, 2020, or beginning November 1, 2024,  
13 those deputy sheriffs and county jailers employed by  
14 any county that is a participating employer in the  
15 System for the first time as a deputy sheriff or  
16 county jailer before November 1, 2020, eight percent  
17 (8%) of allowable compensation as provided in  
18 paragraph (9) of Section 902 of this title; ~~and~~

19 (g) for all CLEET-certified law enforcement agents of the  
20 Department of Human Services Office of Inspector  
21 General as defined by paragraph (38) of Section 902 of  
22 this title, eight percent (8%) of allowable  
23 compensation as provided in paragraph (9) of Section  
24 902 of this title; and

1           ~~(g)~~

2           (h) for all employees except those who make contributions  
3           pursuant to paragraphs (b), (c), (d), (e) ~~and~~ (f),  
4           and (g) of this subsection who make an irrevocable  
5           written election pursuant to paragraph (2) of  
6           subsection A of Section 915 of this title: six and  
7           forty-one one-hundredths percent (6.41%) of allowable  
8           annual compensation.

9           The contributions required by paragraphs (b), (c), (e), and (f)  
10          of this subsection shall be made by a member for not more than  
11          twenty (20) years and thereafter shall be as provided in paragraph  
12          (a) of this subsection.

13          (2) Contributions shall be deducted by each state agency by the  
14          participating employer for such benefits as the Board is authorized  
15          to administer as provided for by law. Employee and employer  
16          contributions shall be remitted monthly, or as the Board may  
17          otherwise provide, to the Executive Director for deposit in the  
18          Oklahoma Public Employees Retirement Fund.

19          (3) Each participating employer shall pick up under the  
20          provisions of Section 414(h)(2) of the Internal Revenue Code of 1986  
21          and pay the contribution which the member is required by law to make  
22          to the System for all compensation earned after December 31, 1988.  
23          Although the contributions so picked up are designated as member  
24          contributions, such contributions shall be treated as contributions

1 being paid by the participating employer in lieu of contributions by  
2 the member in determining tax treatment under the Internal Revenue  
3 Code of 1986 and such picked up contributions shall not be  
4 includable in the gross income of the member until such amounts are  
5 distributed or made available to the member or the beneficiary of  
6 the member. The member, by the terms of this System, shall not have  
7 any option to choose to receive the contributions so picked up

10 Member contributions which are picked up shall be treated in the  
11 same manner and to the same extent as member contributions made  
12 prior to the date on which member contributions were picked up by  
13 the participating employer. Member contributions so picked up shall  
14 be included in gross salary for purposes of determining benefits and  
15 contributions under the System.

16 The participating employer shall pay the member contributions  
17 from the same source of funds used in paying salary to the member,  
18 by effecting an equal cash reduction in gross salary of the member.

19 (4) By September 1, 1989, the System shall refund the  
20 accumulated employee contributions of any member who elects to  
21 retain the member's membership in the Teachers' Retirement System of  
22 Oklahoma, in accordance with Section 17-104 of Title 70 of the  
23 Oklahoma Statutes, to such member. Upon the refund of the

1 accumulated employee contributions referred to in this subsection,  
2 all benefits and rights accrued to such member are terminated.

3 SECTION 5. AMENDATORY 74 O.S. 2021, Section 935.2, is  
4 amended to read as follows:

5 Section 935.2. A. The Oklahoma Public Employees Retirement  
6 System (System) shall establish a defined contribution system for  
7 those persons who first become employed in a full-time equivalent  
8 position or a position which is less than full-time but more than  
9 half-time position and which qualifies for employee benefits,  
10 including but not limited to, health insurance and leave time by any  
11 participating employer of the System, as defined by paragraph (25)  
12 of Section 902 of this title, on or after November 1, 2015. Any  
13 person first licensed by the Department of Rehabilitation Services  
14 as a vending stand operator or managing operator on or after  
15 November 1, 2015, as defined by Section 929 of this title, shall be  
16 eligible for participation in the defined contribution system.

17 B. The provisions of subsection A of this section and the  
18 provisions of this act shall not be applicable to employees who are  
19 initially employed in the positions described in division (i), (ii),  
20 (iii), ~~or~~ (iv), or (vii) of subparagraph (d) of paragraph (24) of  
21 Section 902 of this title, district attorneys, assistant district  
22 attorneys or other employees of the district attorney's office, and  
23 any employees of a county, county elected officials, county  
24 hospital, city or town, conservation district, circuit engineering

1 district, and any public or private trust in which a county, city or  
2 town participates and is the primary beneficiary.

3 C. An employee described by subsection A of this section shall  
4 become a participant in the defined contribution system and the  
5 employee shall not accrue any service credit in the Oklahoma Public  
6 Employees Retirement System as established pursuant to Section 901  
7 et seq. of this title.

8 D. Employees who participate in the defined contribution system  
9 shall be deemed to begin service in the defined contribution system  
10 on the first day of the month following employment.

11 E. An employee who begins participating in the defined benefit  
12 plan on or after November 1, 2015, in one of the positions described  
13 in subsection B of this section, shall continue to participate in  
14 the defined benefit plan only as long as he or she continues to be  
15 employed in a position described in subsection B of this section.

16 F. Any employee employed on or after November 1, 2015, by the  
17 Legislative Service Bureau, State Senate or House of Representatives  
18 for the full duration of a regular legislative session shall be  
19 eligible for membership only in the defined contribution system  
20 regardless of classification as a temporary employee. The temporary  
21 session employee may participate in the defined contribution system  
22 during the regular legislative session at the option of the  
23 employee. Once the temporary session employee makes a choice to  
24 participate, the choice shall be binding for all future legislative

1 sessions during which the temporary session employee is employed.  
2 For purposes of this subparagraph, the determination of whether an  
3 employee is employed for the full duration of a regular legislative  
4 session shall be made by the employer.

5 SECTION 6. This act shall become effective July 1, 2026.

6 SECTION 7. It being immediately necessary for the preservation  
7 of the public peace, health or safety, an emergency is hereby  
8 declared to exist, by reason whereof this act shall take effect and  
9 be in full force from and after its passage and approval.
