AMENDATORY 19 O.S. 2021, Section 547.1, as 16 amended by Section 1, Chapter 14, O.S.L. 2022 (19 O.S. Supp. 2024, 17 Section 547.1), is amended to read as follows: 18 Section 547.1. A. Any Oklahoma sheriff, deputy sheriff, or a 19 reserve deputy sheriff who is assigned to perform duties associated 20 with the National Sheriffs' Association annual conference within 21 Oklahoma County during the month of June 2024, outside of his or her 22 county of employment shall have the same powers and duties as though 23 employed by the Oklahoma County Sheriff's Office sheriff's office 24

1	for which he or she is performing duties. Liability for the conduct
2	of any sheriff, deputy sheriff, or reserve deputy sheriff, while
3	performing duties <del>during the National Sheriffs' Association annual</del>
4	conference or any activities in conjunction with that conference for
5	June 2024 outside of his or her county of employment, shall remain
6	the responsibility of the <del>counties of</del> <u>county in</u> which <del>they are</del> <u>he or</u>
7	she is regularly employed. Salaries, insurance, and other benefits
8	shall be provided in the regular manner by the county in which the
9	sheriffs sheriff, deputy sheriffs sheriff, and or reserve deputy
10	sheriffs are sheriff is regularly employed.
11	B. Any duties assigned to sheriffs, deputy sheriffs, and
12	reserve deputy sheriffs as a result of this section shall terminate
13	on July 1, 2024.
14	SECTION 2. This act shall become effective November 1, 2025.
