9 An Act relating to the practice of alcohol and drug
10 counseling; amending 59 O.S. 2021, Section 1873, as
11 amended by Section 1, Chapter 88, O.S.L. 2023 (59
12 O.S. Supp. 2024, Section 1873), which relates to the
13 Oklahoma Board of Licensed Alcohol and Drug
14 Counselors; eliminating certain educational
15 requirement; removing obsolete language; updating
16 statutory language; and declaring an emergency.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. AMENDATORY 59 O.S. 2021, Section 1873, as
19 amended by Section 1, Chapter 88, O.S.L. 2023 (59 O.S. Supp. 2024,
20 Section 1873), is amended to read as follows:

21 Section 1873. A. There is hereby re-created, to continue until
22 July 1, 2025, in accordance with the provisions of the Oklahoma
23 Sunset Law, the Oklahoma Board of Licensed Alcohol and Drug
24 Counselors, consisting of seven (7) members, to be appointed by the
25 Governor, with the advice and consent of the Senate, as ~~follows:~~
26 provided by subsection B of this section.

1 B. 1. a. ~~Six members who shall be alcohol and drug~~
2 ~~counselors certified by an entity recognized to do~~
3 ~~professional alcohol and drug counseling certification~~
4 ~~in this state; provided, however, five of such members~~
5 ~~shall subsequently secure licensure and one such~~
6 ~~member shall subsequently secure certification,~~
7 ~~pursuant to the provisions of the Licensed Alcohol and~~
8 ~~Drug Counselors Act, no later than January 1, 2005.~~

9 b. ~~Thereafter, five~~ Five members shall be licensed
10 alcohol and drug counselors ~~at the time of~~
11 ~~appointment,~~ and one member shall be certified as an
12 alcohol and drug counselor ~~at the time of appointment.~~

13 c. ~~Pursuant to.~~ Each such member shall be licensed or
14 certified in good standing and shall have at least
15 three (3) years of experience in the practice of
16 alcohol and drug counseling in this state. Of the
17 members appointed under the provisions of this
18 paragraph, the Governor shall appoint:

19 (1) a. four members from a list of names submitted by the
20 Oklahoma Drug and Alcohol Professional ~~Counselors~~
21 Counselor Association,

22 (2) b. one member from a list of names submitted by the
23 ~~Oklahoma Substance Abuse Services Alliance~~ Oklahoma
24 Behavioral Health Association, and

1 ~~(3)~~ c. one member from a list of names submitted by the
2 Oklahoma Citizen Advocates for Recovery and Treatment
3 Transformation Association.

4 ~~d.~~

5 2. One member shall be appointed from and shall represent the
6 general public. Such member shall be a resident of this state who
7 has attained the age of majority and shall not be, nor shall ever
8 have been, a licensed or certified alcohol and drug counselor, or
9 the spouse of a licensed or certified alcohol and drug counselor, or
10 a person who has ever had any material financial interest in the
11 provision of alcohol and drug counseling services or has engaged in
12 any activity directly related to the practice of alcohol and drug
13 counseling.

14 ~~2. The composition of the Board shall include five members who~~
15 ~~hold a master's or higher degree and one member whose highest degree~~
16 ~~held is a bachelor's degree.~~

17 ~~3. The Governor shall appoint the members to the Board no later~~
18 ~~than July 1, 2004.~~

19 ~~B. Each member of the Board appointed as a licensed alcohol and~~
20 ~~drug counselor shall:~~

21 ~~1. Be certified or licensed to engage in the practice of~~
22 ~~alcohol and drug counseling in this state and shall be in good~~
23 ~~standing; and~~

1 ~~2. Have at least three (3) years of experience in the practice~~
2 ~~of alcohol and drug counseling in this state.~~

3 C. ~~Two of the members initially appointed shall serve three~~
4 ~~year terms; two shall serve four year terms and three shall serve~~
5 ~~five year terms, as designated by the Governor. Thereafter, the The~~
6 terms of all members shall be five (5) years.

7 D. A vacancy on the Board shall be filled in the same manner as
8 the original appointment for the balance of the unexpired term.
9 Members may succeed themselves but shall serve no more than two
10 consecutive terms. Each member shall serve until a successor is
11 appointed and qualified.

12 E. Members of the Board may be removed from office for one or
13 more of the following reasons:

14 1. The refusal or inability for any reason to perform the
15 duties of a Board member in an efficient, responsible and
16 professional manner;

17 2. The misuse of office for pecuniary or material gain or for
18 personal advantage for self or another;

19 3. A violation of the laws or rules governing the practice of
20 alcohol and drug counseling; or

21 4. Conviction of a felony as verified by a certified copy of
22 the record of the court of conviction.

1 F. Members of the Board shall serve without compensation, but
2 shall be reimbursed for actual and necessary travel expenses as
3 provided in the State Travel Reimbursement Act.

4 SECTION 2. It being immediately necessary for the preservation
5 of the public peace, health or safety, an emergency is hereby
6 declared to exist, by reason whereof this act shall take effect and
7 be in full force from and after its passage and approval.
