7 A Joint Resolution approving proposed permanent rules
8 of certain state agencies; and directing
9 distribution.

11 WHEREAS, pursuant to Section 308.3 of Title 75 of the Oklahoma
12 Statutes, the Legislature shall have a joint resolution prepared for
13 consideration each session.

14 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE AND THE HOUSE OF
15 REPRESENTATIVES OF THE 1ST SESSION OF THE 60TH OKLAHOMA LEGISLATURE:

16 SECTION 1. The Legislature hereby approves all proposed
17 permanent rules filed on or before February 1, 2025, by the Oklahoma
18 Abstractors Board, Oklahoma Accountancy Board, Alcoholic Beverage
19 Laws Enforcement Commission (ABLE Commission), Board of Governors of
20 the Architects, Landscape Architects and Licensed Interior Designers
21 of Oklahoma, Oklahoma Department of Commerce, State Election Board,
22 State Fire Marshal Commission, Oklahoma Horse Racing Commission,
23 Insurance Department, Department of Labor, Oklahoma Lottery
24 Commission, Oklahoma Medical Marijuana Authority, Oklahoma New Motor

1 Vehicle Commission, Oklahoma Public Employees Retirement System,
2 Real Estate Appraiser Board, Oklahoma Real Estate Commission,
3 Secretary of State, Oklahoma Department of Securities, Oklahoma Tax
4 Commission, and the Oklahoma Used Motor Vehicle, Dismantler, and
5 Manufactured Housing Commission, except for:

6 1. Oklahoma Department of Securities 660:2-11-5, disapproving
7 the amendments to subsection (d), and restoring the previous rule
8 language;

9 2. Oklahoma Department of Securities 660:2-11-6, disapproving
10 the amendments to subsection (d), and restoring the previous rule
11 language;

12 3. Oklahoma Medical Marijuana Authority 442:10-7-1,
13 disapproving the amendment to subsection (a) after the word
14 "ounces", and before the period;

15 4. Oklahoma Medical Marijuana Authority 442:10-7-2,
16 disapproving the amendment to subsection (c) after the word
17 "ounces", and before the period; and

18 5. Real Estate Appraiser Board 600:10-1-7, disapproving
19 subsection (e).

20 SECTION 2. The Secretary of State is hereby directed to
21 distribute copies of this resolution to the Governor and the editor
22 of "The Oklahoma Register".
