**Research Analysis**

The floor amendment to HB 3130 strikes behavioral health care services or mental health counseling from the list of things that are not included as gender transition procedures. The amendment also adds psychologists, counselors, therapists, social workers, and behavioral health practitioners to the definition of *health care provider*.

HB 3130 prohibits any state agency, subdivision, employee, contractor, or public institution from doing the following:

- Provide, allocate, or reimburse any state funds for gender transition procedures;
- Facilitate, refer, or encourage the provision of such procedures; and
- Contract with any entity that knowingly promotes or performs such procedures.

Any violation of this from a state employee will constitute grounds for immediate termination and forfeiture of benefits.

The measure also provides that a parent or guardian's decision to withhold consent for gender transition procedures or related social transitions will not by itself count as abuse, neglect, or grounds for loss of custody. Any government agency or court that violates this will be subject to civil liability and injunction. If any provision of this measure is found invalid by a court, the rest must remain in full effect. Any challenge to this measure will be adjudicated exclusively in the state and will be governed by strict scrutiny standards applicable to state sovereign authority over public health and child welfare.

The measure adds that unprofessional conduct will include knowingly performing, attempting to perform, or referring a child for a gender transition procedure. This will also be included as unprofessional conduct for physicians assistants. The Oklahoma Board of Nursing and the State Board of Osteopathic Examiners will be able to take discipline actions for professionals knowingly performing, attempting, or referring a child for a gender transition procedure. Health care providers are banned from undertaking any of these actions and no person must knowingly aid or abet the performance or referral of a gender transition procedure on a child, in-state or out-of-state.

**Fiscal Analysis**

HB 3130 prohibits the use of state funds for gender transition procedures and clarifies what is classified as unprofessional conduct and subject to disciplinary action. As amended, the measure is not expected to have a direct fiscal impact on the state budget or appropriations.
