Research Analysis

The policy committee recommendation for HB 3818 allows an individual to deduct contributions made to a qualified insured loss savings account for their residence or vehicle from their taxable income. Interest earned on these accounts is also exempt from income tax. Account funds may only be withdrawn to pay deductibles for the taxpayer's primary residence or up to three vehicles or to cover expenses from damage, disaster, or accidents affecting those assets, regardless of whether insurance reimburses the loss.
