**Bill Analysis**

SB 172 authorizes Oklahoma Firefighters Pension and Retirement System, Uniform Retirement System for Justices and Judges, Oklahoma Public Employees Retirement System, Oklahoma Law Enforcement Retirement System, Teachers' Retirement System of Oklahoma, Oklahoma Public Employees Retirement System, and the Oklahoma Police Pension and Retirement System boards to approve a 2% cost-of-living adjustment (COLA) when each respective System's funding ratio exceeds 80%, provided the COLA does not cause the System to fall below the 80% funding ratio. A subsequent COLA may be approved each time the ratio increases by 2.5%. If the funding ratio meets or exceeds 100%, each System may approve a COLA at any time, provided the adjustment does not cause the funded ratio to drop below 100%.
